It also serves as an op-portunity to introduce the tar-geted countries for the event, including the UK, Germany, Russia, Spain, Italy, India, Egypt and the Gulf countries, to the appealing opportuni-ties offered by Bahrain to the tourism industry and inves-tors.

(Al Bilad 08.08.2023) India has banned the use of Chinese components in the drone: Amidst the recent tensions that marred the relationship between the two countries, it seems that India has begun in the past months to implement new standards towards imports from China. India in recent months has barred domestic manufacturers of military drones from using components made in China over concerns about security vulnerabilities, according to four defence and industry officials and documents reviewed by Reuters. India's security leaders have expressed concern about the possibility of intelligence gathering through Chinese-made parts used in the drone's communications system, cameras and drivers. Last week, the Chinese Ministry of Commerce announced the imposition of export controls with regard to some parade-related equipment. The ban on Chinese parts increased the cost of manufacturing military parades domestically, and forced Indian manufacturers to source or source components elsewhere.

(The Daily Tribune 15.08.2023) Foxconn boss sees potential to invest billions in India: Taiwanese tech giant and key Apple supplier Foxconn said yesterday it sees the potential to invest "several billion dollars" in India, with the firm looking to diversify its manufacturing away from China. Foxconn -- also known by its official name Hon Hai Precision Industry -- is the world's biggest contract electronics manufacturer and assembles devices for many companies, most notably Apple's iPhones. It operates in more than two dozen countries but the bulk of its operations is based in China -- a dependence it is looking to reduce, with media reports of major investments in India.

generation iPhone 15 is beginning production in Tamil Nadu, in an effort to further narrow the gap between its India operations and main manufacturing base in China. A Foxconn Technology Group plant in Sriperumbudur is preparing to deliver the newest devices only weeks after they start shipping from factories in China, as the company seeks to swiftly increase the volume of new iPhones coming from India, people familiar with the matter said.

IndiGo, which controls about 58 percent of India's domestic market, launched two new direct flights last Friday connecting Ahmedabad with Jeddah and Abu Dhabi.

(The Daily Tribune 17.08.2023) Vietnam rice exporters negotiate higher prices: VIETNAMESE exporters have renegotiated higher prices for around half a mil-lion metric tonnes of rice, two trade sources said, as glob-al prices climbed to 15-year highs following India's ban on overseas sales last month. The export ban by India, which accounts for 40 per cent of world rice supplies, has taken out 10 million tonnes of supplies from the international market.

(BNA/Al Watan 19.08.2023) India imposes a 40% tax on onion exports amid rising inflation: India has imposed a tax of up to 40 percent on onion exports, as Prime Minister Narendra Modi seeks to curb inflation ahead of a key election, Bloomberg News reported Saturday. A notice to the Ministry of Finance said today that the export tax will come into effect immediately, to continue until the end of the year.

(Gulf Daily News/Al Ayam 20.08.2023) India imposes 40 per cent duty on export of onions: INDIA will impose with immediate effect a 40 per cent export duty on onions up to December 31 in an attempt to improve domestic availability of the vegetable, the ministry of finance said in a notification yesterday. The duty imposed by the world's biggest exporter of onions will help New Delhi dampen local prices ahead of key state elections later this year but will force Asian buyers to shell out more, as other regional exporters have limited supplies. "The export duty will make Indian onions more expensive than those from Pakistan, China, and Egypt. This will naturally lead to lower exports and aid in reducing local prices," said Ajit Shah, an exporter based in Mumbai.

(Gulf Daily News/Akhbar Al Khaleej 21.08.2023) India's decision to impose export duty on onion 'won't affect Bahrain': FRUIT and vegetables trader Reda Al Bustani said Bahrain will not be affected by the Indian government's decision to impose an export duty of 40 per cent on onions until the end of this year, in a bid to check price rise and improve supplies in the domestic market. This is due to the availability of several alternatives to importing onions from several other countries such as Yemen, Egypt and Pakistan, he said, pointing out that prices will be based on supply and demand.

(Gulf Daily News 21.08.2023) Saudi Arabia and India sign accord on digital economy: SAUDI Arabia's Ministry of Communications and Information Technology yesterday signed a co-operation agreement on digitisation and electronic manufacturing with India, reported the Saudi Arabian Press Agency (SPA). The agreement was signed by Saudi Minister of Communications and Information Technology Abdullah Alswaha and Indian Minister for Railways, Communications, Electronics and Information Technology Ashwini Vaishnaw. The agreement seeks to enhance Saudi-Indian co-operation in the fields of digital infrastructure, e-health, and e-learning, and to strengthen the two countries' partnership in digital research and innovation and the use of emerging technologies.(BNA 21.08.2023) Moroccan Foreign Minister discusses with his Indian counterpart regional and international issues of common concern: The Moroccan Minister of Foreign Affairs, Nasser Bourita, discussed, during a phone call with his Indian counterpart, Subrahmanyam Jaishankar, ways to enhance bilateral cooperation between the two countries, as well as discussing regional and international issues of common interest, especially Morocco's relations with the "BRICS" group.

develop economic partnerships. Mr Fakhro was speaking as he received Vinod K Jacob, the newly appointed Indian Ambassador to Bahrain. The meeting reviewed bilateral relations and ways to enhance co-operation in various sectors, especially economics and investment.

(Gulf Daily News 23.08.2023) India 'not planning to restrict parboiled rice exports': INDIA is not considering imposing any restrictions on exports of non-basmati parboiled rice, food secretary Sanjeev Chopra said yesterday. Last month, India surprised buyers by imposing a ban on the export of widely consumed non-basmati white rice, following a ban on broken rice exports last year. "There is no proposal as of now to restrict parboiled rice exports," Chopra said in response to questions about whether India was considering imposing an export tax or introducing a floor price for parboiled rice exports.

(Al Ayam/Al Bilad 26.08.2023) India imposes a 20% export duty on parboiled rice: India imposed a 20% tariff on exports of parboiled rice with immediate effect, a move that could further reduce shipments from the world's largest exporter and raise global rice prices, which are already trading near 12-year highs.

(Gulf Daily News/Akhbar Al Khaleej 27.08.2023) India's move to impose export duty on rice 'will affect prices': DECISION by the Indian government to levy a 20 per cent export tax on parboiled rice with immediate effect, according to a notification by the finance ministry late on Friday, will inevitably affect rice prices in global and local markets over time, said businessman Ibrahim Zainal. However, this depends on stock quantities of rice in the country, and the tax period imposed by India, as international prices change on a daily basis, he said.

(Gulf Daily News/Al Watan 28.08.2023) India sets price for export of basmati rice: INDIA has imposed a \$1,200 per tonne minimum export price (MEP) on basmati rice shipments, the government said yesterday, as the world's biggest exporter tries to calm local prices. The south Asian country in July banned exports of non-basmati white rice and on Friday imposed 20 per cent duty on the exports of parboiled rice. But after the ban, some traders were classifying non-basmati white rice as basmati to overcome the export restriction, the government said. The MEP would help authorities ensure that non-basmati rice is not exported as basmati rice, they said.

This falls under the customs items of the GCC Unified Customs Tariff (GCC Tariff), according to Law 48/2011 approving Antidumping, Countervailing Measures, and Safeguard Measures Rules of Implementation. (Akhbar Al Khaleej 28.08.2023) India imposes more restrictions on rice exports... and global prices are in danger: India imposed more curbs on shipments of rice to ensure its food security, a move by the top exporter that's likely to further squeeze global supplies of the grain. According to the German News Agency. India has now restricted overseas sales of all non-basmati varieties, which account for about 80% of its total rice shipments. Its share in the global rice trade is about 40%.

(Gulf Daily News 29.08.2023) GCC seeking to restart FTA talks says India: THE Gulf Co-operation Council (GCC) is seeking to restart negotiations on a free trade agreement (FTA) with India, Zawya has reported citing a top minister of the world's fifth-largest economy. The report quotes India's Commerce and Industry Minister Piyush Goyal as saying to The Financial Express that while India has signed a Comprehensive Economic Partnership Agreement (CEPA) with the UAE, some countries have individually sought an agreement.

The figures, released by the Economy Ministry, underline the continued upward trajectory of the nation's foreign trade, which has achieved quarter-on-quarter growth since 2020. The UAE's non-oil exports to its top ten trading partners grew by a total of 22.9pc. Switzerland headed the top five non-oil export destinations, while Türkiye made a significant leap to second.
