IV. Any other submission

- 1. Significant increase in tourist arrivals and nights in December 2023 compared to December 2022. In December 2023, there were 389 thousand tourist arrivals and 839 thousand tourist nights in commercial accommodation establishments, which was an increase of 18.2% in tourist arrivals and of 13.4% in tourist nights compared to December 2022. Domestic tourists realised 161 thousand arrivals and 303 thousand nights, which was 19.2% more arrivals and 21.2% more nights than in December 2022. Foreign tourists realised 228 thousand arrivals and 536 thousand nights, which was 17.5% more arrivals and 9.4% more nights than in December 2022. Tourists from Slovenia and Austria realised a third of foreign tourist nights. The most foreign tourist nights in December 2023 were realised by tourists from Slovenia and Austria, namely 176 thousand nights, which was 32.8% of the total realised foreign tourist nights. Tourists from Slovenia realised 93 thousand nights, mostly in the County of Istria, while tourists from Austria realised 83 thousand tourist nights, mostly in the County of Primorje-Gorski kotar. These were followed by the nights realised by tourists from Germany (11.3%), Italy (8.6%), Bosnia and Herzegovina (6.3%), the USA (4.2%) and Serbia (3.9%). All these countries recorded an increase in tourist nights in December 2023 compared to December 2022. In the last month of 2023, tourists spent the most nights in the City of Zagreb. The City of Zagreb recorded 234 thousand tourist nights, which was 27.9% of the total number of tourist nights realised in Croatia and an increase of 11.5% compared to December 2022. - 2. Average net earnings reach 1,191 euro in December 2023. For December 2023, the average monthly paid off net earnings per person in paid employment in legal entities in the Republic of Croatia amounted to 1,191 euro, which represented a nominal decrease of 1.4% and a real one of 0.9%, as compared to November 2023. The average monthly paid gross earnings per person in paid employment in legal entities in the Republic of Croatia for December 2023 amounted to 1,620 euro, which represented a nominal decrease of 3.5% and a real one of 3.0%, as compared to November 2023. The highest average monthly paid net earnings per person in paid employment in legal entities for December 2023 were paid in the activity Manufacture of coke and refined petroleum products and amounted to 1,795 euro, while the lowest earnings were paid in the activity Manufacture of wearing apparel and amounted to 739 euro. The highest average monthly paid gross earnings per person in paid employment in legal entities for December 2023 were paid in the activity Manufacture of coke and refined petroleum products and amounted to 2,662 euro, while the lowest earnings were paid in the activity Manufacture of wearing apparel and amounted to 920 euro. The average monthly paid net earnings per person in paid employment in legal entities in the Republic of Croatia for December 2023 were 13.9% higher in nominal terms and 9.0% higher in real terms, as compared to the same month of the previous year. The average monthly paid gross earnings per person in paid employment in legal entities in the Republic of Croatia for December 2023 were 13.5% higher in nominal terms and 8.6% higher in real terms, as compared to the same month of the previous year. Median net earnings for December 2023 amounted to 1,005 euro, while median gross earnings amounted to 1,334 euro. (Source: Croatian Bureau of Statistics)

- 3. Prices in January 2024 higher by 4.1% at the annual level. In January 2024 compared to January 2023 (at the annual level), the prices of goods and services for personal consumption, measured by the consumer price index, increased by 4.1% on average. Compared to December 2023 (at the monthly level), they decreased by 0.4% on average. Observing the main divisions of the ECOICOP classification, at the annual level, the highest increase on average in consumer prices was recorded in the following divisions: Restaurants and hotels, of 10.0% (contribution to the growth of +0.51 percentage points), Food and non-alcoholic beverages, of 6.5% (+1.72 percentage points), Health, of 5.5% (+0.17 percentage points), Education, of 5.4% (+0.04 percentage points), Miscellaneous goods and services, of 4.6% (+0.29 percentage points), Recreation and culture, of 3.9% (+0.20 percentage points), Alcoholic beverages and tobacco as well as Clothing and footwear, of 3.8% in each division (contribution to the growth of +0.19 percentage points in the division Alcoholic beverages and tobacco and of +0.24 percentage points in division Clothing and footwear), Transport, of 3.7% (+0.51 percentage points), and Communication, of 3.0% (+0.16 percentage points). In January 2024, compared to January 2023 (at the annual level), the prices of goods and services for personal consumption, measured by the harmonised index of consumer prices, increased by 4.8% on average. Compared to December 2023 (at the monthly level), they decreased by 0.3% on average. (Source: Croatian Bureau of Statistics)
- 4. In the fourth quarter of 2023, GDP increased by 4.3% in real terms compared to the same quarter of 2022. In the fourth quarter of 2023, GDP increased in real terms by 4.3% compared to the same quarter of 2022. The first estimate shows that the quarterly gross value added (GVA) increased in real terms by 2.8% in the fourth quarter of 2023 compared to the same quarter of 2022, based on non-seasonally adjusted data. The quarterly growth of GVA was recorded in most activity groups and it was mostly influenced by Wholesale and retail trade, transportation and storage, accommodation and food service activities, and Construction. Household consumption increased in real terms by 5.3%, mainly due to an increase in turnover from retail trade. Government spending increased by 0.2% in real terms in the fourth quarter of 2023, as compared to the same period of the previous year. In the fourth quarter of 2023, the export of goods and services decreased in real terms by 4.4% and the import of goods and services by 7.1%. (Source: Croatian Bureau of Statistics)

f) Sectoral insight from Croatia

Croatia Oil & Gas Report

Key view

The upstream outlook for Croatia is weak owing to a lack of investment and modest reserves, though recent licencing rounds provide some upsides. Croatia has seen a modest increase in exploration in recent years, but the uptick is unlikely to reverse the bearish outlook for the upstream sector. Moreover, lower oil prices as well as limited reserves and acreage are likely to deter investment in Croatia's modest upstream.

Industry Forecast

Upstream Exploration

Croatia has stepped up licencing activity in recent years, though any gains to reserves and production are likely to be modest. Though Croatia's offshore is prospective, domestic opposition will prevent exploration there in the medium term.

Croatia's estimated 59.6mn bbl of proven oil reserves, as of 2024, are located largely southeast of Zagreb, as well as along the Hungarian border and on the Adriatic coast. Domestic exploration efforts have focused on the Pannonian Basin. Croatia's offshore remains prospective but domestic opposition will prevent exploration for oil for the foreseeable future. On the back of new investment in onshore and, to a lesser degree, offshore gas exploration, there is upside risk to Fitch's reserves outlook. However, based on recent E&P activity, the country's upstream prospects remain bearish, and future discoveries are likely to only slow rather than reverse the current decline in the output of reserves and production.

Upstream Oil Production

Enhanced oil recovery projects present some modest upsides to Fitch's forecast, but more significant gains are unlikely without greater investment. Domestic opposition will deter offshore investment for the foreseeable future despite the upside potential.

Crude oil production currently takes place at some 33 fields, and despite the recent exploration success by INA, there is little immediate prospect of major oil accumulations being found and developed. Based on Fitch's forecast methodology, in 2024 crude and liquid oil production is estimated to come in at 10,700b/d, slipping to 7,400b/d by 2032. Crude oil production in Croatia is set to continue its decline, having peaked at around 48,000b/d in 1994. Though both onshore and offshore acreage remain prospective, any gains are unlikely to completely reverse the overall fall in liquids output.

INA has said that it would invest in new wells to offset the declines from mature fields, while the government has said that it would work to increase domestic output by 2030 and would focus on onshore areas. The plan could provide some modest upside to Fitch's forecast, though the overall outlook for Croatia remains bearish.

Modest investment in Ivanic and Zutica was begun in 2015 and continued into 2016, according to INA, which also plans to complete an artificial lift optimization project on the Đeletovci oil field. These projects have priority in the domestic portfolio, but any more meaningful increases in output are likely to come from new exploration.

Moreover, INA has confirmed that it had delayed some planned investment because of the decline in global oil prices, creating further downside risks for Fitch's forecast.

There is some upside from potential increased investment in onshore acreage. Licencing activity will target both proven and unproven acreage. Offshore acreage remains attractive and prospective for liquids, but environmental opposition is likely to inhibit investment here for the foreseeable future.

Upstream Gas Production

Modest upstream investment will partly offset the falling production from mature fields. However, without a major discovery, Croatia is unlikely to see significant gains, and output is expected to decline steadily over the forecast period.

Croatia has benefitted from modest investment in the upstream natural gas sector. Fitch maintains that Croatia's chances to reverse this decline will more likely come from nascent offshore exploration in the Adriatic Sea. Croatia is unlikely to approve offshore oil exploration for the foreseeable future because of domestic opposition and unclear maritime boundaries, but the government has signalled openness to investment in Adriatic gas fields. To date, there have been indications of serious efforts to attract investors to potential gas-rich offshore acreage, but no tangible progress or commitments have materialised.

It remains unclear when exploration would be permitted and whether investors would be interested given indications from the 2015 bidding round that international oil companies favoured oil-prone acreage over gas.

INA has invested in gas development in Northern Croatia, but these fields remain too small to offset the country's falling output. The company, for example, signed contracts with four local engineering firms to work on the Medjimurje project, which entails the development of three gas fields: the Vukovec, Vukanovec and Zebanec fields in Medjimurje County. The estimate for total commercial reserves at the three fields is modest, at about 1bcm.

Refining

Croatia's underperforming Sisak refinery ceased processing crude in Q419 and was removed from Fitch's downstream capacity forecast in 2020. However, refined fuels output will see a boost from Industrija Nafte's USD617mn modernisation of the 90,000b/d Rijeka refinery, which is expected to come online by mid-2024.

Refined Fuels Consumption

Weak domestic demand and a small market size continue to weigh on the outlook for the domestic refined products market. Energy efficiency gains and higher taxes on energy consumption will also depress demand for fuels. A number of power plants that previously relied on heavy fuel oil have already switched to, or are scheduled to transition to, reliance on natural gas as fuel. This, alongside upgrades at downstream facilities, will see a decline in both the production and consumption of heavy fuel oil. In the transport sector, flat or negative growth is expected because of more efficient vehicles and government policies aimed at increased energy efficiency.

Gas Consumption

Consumption of natural gas is expected to rise at a moderate rate owing to greater demand from the power and transport sector. Croatia's LNG import terminal may boost consumption, but persistent weakness in the economy will remain the decisive factor in determining aggregate consumption levels. Consumption is set to rise at a yearly rate of 3.3-3.7% over Fitch's forecast period from 2024. This will lead to increased gas import requirements over the decade.

The weak economy remains a source of downside risk for gas demand, with Croatia struggling after several years of weak or negative growth. Suppressed economic activity could reduce demand for gas from industries and households. The LNG import terminal commenced commercial operations in January 2021 and offers some upside risk to imports.

The power sector has increased its reliance on natural gas as a fuel for generation. In January 2020 HEP announced that work had begun on a gas-fired combined cycle power plant at its KKE EL-TO Zagreb site in Croatia. The facility, which will have power output of 150MW, highlights Croatia's shift to natural gas to generate electricity.

This shift away from oil is expected to continue over the coming decade. There has also been a steady increase in the use of LPG as a fuel for the transport sector.

Oil Trade

Though there is upside risk from increased exploration, domestic crude production will remain modest, resulting in an ever-growing reliance on imports. Croatia will remain a modest crude importer

with total liquid imports expected to rise gradually to reach around 66,700b/d by 2032 as domestic output declines.

Gas Trade

In response to strong demand, officials have confirmed plans to expand the Krk LNG terminal, which came online in 2021, to a capacity of 6.1bcm per annum at a cost of USD33mn. The expansion is planned to come online in the summer of 2025 and should bolster demand for LNG.

Competitive Landscape Summary

The main government vehicle is Industrija Nafte (INA), which is under the control of Hungary's Magyar Olaj- és Gázipari Részvénytársaság (MOL), its main shareholder (49%). MOL has been in dispute with the government over control of INA. The Croatian government, which holds a 44.8% stake in INA, has repeatedly said it plans to repurchase the MOL stake in INA.

Major international oil companies have a limited presence in the country. Eni sold its upstream assets in Croatia to INA in 2018.

Smaller players, such as Nigeria-based Oando and Canada-based Vermilion, have entered the market since 2015 as Croatia stepped up onshore licensing activity.

INA is responsible for most of the oil production, the bulk of the gas supply and the whole of the Croatian refining system. It also accounts for more than half of the fuel distribution segment, where local and foreign companies are also present.

INA has more than 438 domestic fuel retail outlets, produces around 65,500boe/d of oil, gas and condensates and has a refining capacity of 102,060b/d after the Sisak facility ceased processing crude in late 2019. According to media reports, the company is now considering separating its petrol stations into a new company.

The Croatian Government has stepped up its efforts to buy out MOL's 49% stake in INA, but the plan faces political, legal and financial obstacles.
