A. Greek global trade:

The Greek global trade in the 12-month period from January to December 2022 was 154,971.0 million dollars.

Greek global exports (57,565.3 million dollars) recorded an increase of +21.5% and global imports (97,405.7 million dollars) increased by +26.6% in comparison with the corresponding period of 2021. Exports to India were 0.43% of the global Greek exports and Imports from India were 1.16% of the global Greek imports.

Greek global exports (in USD million) from January to December 2022 originated by 55.1% from EU countries and 44.9% from third countries.

Greek global imports (in USD million) from January to December 2022 originated by 42.9% from EU countries and 57.1% from third countries.

1.	15/04/2022	The 8th Session of India - Greece Joint Economic Committee (JEC) held in Athens	The JEC was set up in 1983 and meets alternatively in Delhi and Athens. The 7th session of the JEC was held in Delhi in November 2016. Hon'ble Minister of State for Commerce and Industry, H.E. Mrs. Anupriya Patel, co-chaired the 8th session of India-Greece JEC with Deputy Minister for Foreign Affairs of the Hellenic Republic, H.E. Mr. Konstantinos Fragkogiannis. Discussions were held on a wide-range of issues in the economic, commercial and related areas such as: agriculture, research & innovation, tourism, air services, maritime affairs, investment, energy, education, health & pharmaceuticals, etc. At the conclusion of the meeting a Protocol was signed by both the Ministers with the aim to strengthen and further develop the economic and trade relations to the mutual benefit of both the countries. Simultaneously, a Memo- randum of Understanding (MoU) on Enhancing Bilateral Investment Relations between Invest India, National Investment Promotion and Facilitation Agency of India and Enterprise Greece was also exchanged by both the Ministers. Hon'ble MoS (C&I) also met with the Greek Minister for Rural Development and Food, H.E. Mr. Georgios Georgantas, and the Greek Deputy Minister for Research and Technology, H.E. Dr. Christos Dimas on 14 April, 2022 for further collaboration and strengthen relations between two countries.

			The Indian delegation (2 members of NJB and 6 Indian Jute Exporters) had fruitful meetings with representatives of the Athens Chamber of Commerce. They also received a very good feedback from Greek buyers.
3.	06/09/2022	Business event, at the Embassy's premises	Mission organized the Business Event "Round- table Business Meet/Interaction" which was hosted by the Ambassador. In the event participated representatives from the Athens Chamber of Commerce and Industry, Piraeus Chamber of Commerce and Industry, Athens International Airport S.A. and Enterprise Greece. The event focused on the further promotion of the bilateral trade relations and the presenta- tion of the investment initiatives of the Indian Government.
4.	10-18/09/2022	Participation in Trade Fair (86th Thessaloniki International Fair)	India Trade Promotion Organization (ITPO) participated in the 86th Thessaloniki Interna- tional Fair (TIF) 2022, at Thessaloniki Interna- tional Exhibition & Congress Centre. TIF is the largest annual commercial trade show in Greece. The 86th TIF 2022 had over 200.000 visitors,19 international and state participations and almost 1500 exhibitors. ITPO participated with an Indian pavillion and 33 Indian companies under its banner including three women entre-preneurs. The Indian products exhibited were handicraft items, Zari items, Bed- sheets, Gems & Jewellery, Home décor, Shawls, Scarves, Leather Bags, Purse, etc. Indian pavillion was visited by people of all age groups and the Indian exhibitors were satisfied with the outcome of the fair. The majority of them expressed their interest to participate in the next edition of the Fair.

		Palace, Thessaloniki	Preferred Investment Destination" in Thessaloniki. The event was hosted by the Ambassador who highlighted the business and investment oppor- tunities in India. The Deputy Minister of Interior Responsible for Macedonia – Thrace, the Deputy Mayor of Thessaloniki and other prominent people from Thessaloniki were present in the event.

Mission arranged a meeting with Athens Chamber of Commerce & Industry (ACCI). The FICCI FLO (FICCI Ladies Organization) is an All-India forum for women, having its head-quarters in New Delhi and 19 chapters across India, representing over 8000 women entrepreneurs and professionals. The objective of the visit was the creation of synergies and partnership (through MOU's etc.) with Greek Associations of women enterpreneurs. After the meeting with ACCI, both sides expressed their interest for further collaboration.
7.	18-20/11/2022	Participation in the 37th PHILOXENIA Trade Fair, at Thessaloniki Inter- national Exhibition Center	Mission participated in the 37th PHILOXENIA 2022, at Thessaloniki International Exhibition Center. PHILOXENIA is an international tourism trade fair, held annually at the International Exhibition and Congress Center (HELEXPO), Thessaloniki, under the auspices of Ministry of Interior (Macedonia and Thrace), Hellenic Republic and SETE (Association of Greek Tourism Enterprises). Philoxenia had also two parallel exhibitions: Hotelia and Real Estate North Expo and Armenia was the honoured country this year. Mission set up a booth to promote the strength, diversity and potential of Indian tourism and got a huge response from international visitors, tour operators and real

			estate agents who were keen to cooperate with Indian tour operators (in- and outbound). Especially tour operators from Bulgaria, Serbia, North Macedonia, Romania, etc., enquired about tourist packages from India to their countries via Greece and contact details of good quality hotels across India. Honorary Consuls and Diplomats of other countries like Vietnam, Sloval Republic, Philippines, etc. visited Mission's booth.

Rajendran, Cd'A and Commercial Repre- sentative, met with the Mayor of Kalamata Mu- nicipality Mr. Thanassis Vassilopoulos and the President of the Messinian Chamber of Com- merce and Industry Mr. Evangelos Xygoros. The Messinian Chamber represents over 12,000 member companies. The area of Messinia is famous for the produ- ction and processing of extra virgin olive oil, the famous Kalamata Olives, dried figs, tobacco pro- ducts, raisins etc. while in recent years it has also seen strong tourism growth. The Greek side informed that some Greek companies have already trade relations with Indian ones. The discussions focused on the further enhancement of Trade and Commerce activities between stakeholders from Messinia/Greece and India.

Mr. Nirmesh Kumar, Commercial Attache and officials from the Embassy partici-pated in the business session with the President Mr. Vangelis Xygo-ros and members of the Chamber's Administration and businessmen of the Prefecture. Discussed enhancing Trade and

Commerce between the stakeholders in Kalamata (Greece) and India. The focus of the meeting was the promotion and development of Greek-Indian relations in the economic and business sector, the strengthening of trade and development of the two countries.
