

Overview of General Barriers to FDI in Hungary:

Regulatory barriers and administrative burden are affecting all sectors but particularly energy, construction, and banking: The overall administrative burden, including start-ups, negatively affects investment decisions. The instability of the regulatory framework, with frequent and unpredictable regulatory changes, creates uncertainty for investors and is hindering both internal investment and FDIs.

The Hungarian government imposes a 100% offset requirement for defined sector investments over HUF 1bln (EUR 2.8 mln). Efficiency of procedures in construction and environmental permits is insufficient; corruption also raises risk for investors. There is no requirement that investors must purchase from local sources, but the EU Rules of origin applies.

Ownership restrictions (all non-EU)

according to the 2014 Land Law, only private Hungarian or EU citizens resident in Hungary with a minimum of three years experience of working in agriculture or holding degree in agriculture can purchase farmland, which is limited to 300 hectares. All others may lease farmland. All farmland purchases must be approved by a local land committee and Hungarian authorities, local farmers and young farmers must be offered a chance to purchase the land first. Up to 1200 hectares for a maximum of 20 years may be leased.

Price controls in consumer facing sectors and others considered to be of strategic importance.

The Hungarian government regulates the prices of certain goods, setting the upper and lower limits to which the private sector must adhere. Sectors include energy, pharmaceuticals. Cuts on regulated utilities prices have put considerable pressure on private utilities companies, decreasing profit margins and adding to an increasingly difficult operating environment.

State intervention in Banking, energy, agriculture, media, telecommunications, and retail sectors.

Since 2012 government has invested in state-owned enterprises with the objective of lessening the participation of foreign-owned competitors, especially in the energy sector. From 1 Jan 2019, the chemical industry, the telecom sector, vehicle construction, metallurgy, optics and electric equipment production, the defence industry, water and sewage management, the financial sector, food industry and agriculture, production of construction materials, state administration, health care, wage management, transport and tourism sectors have been added. Foreign investors in the targeted sectors have expressed concerns that the tax regime has become unpredictable and the additional levies appear to have been aimed against some industries with a high level of foreign ownership.

Basic Rules of The Protection of Strategic assets Concerning Foreign investments

The European Commission has issued Communication 2020/C 99 i/01 in which it has given guidance to the Member States of the EU concerning the protection of Europe's strategic assets from the foreign direct investment, ahead of the application of Regulation (EU) 2019/452 (FDI Screening Regulation) which is applicable from 11 October 2020.Commission Delegated Regulation (EU) 2020/1298 of 13 July 2020 amended the Annex to Regulation (EU) 2019/452.

Hungary first adopted FDI screening mechanisms by act LVII of 2018 for FDIs violating the security interests of the country, then in the economic crisis caused by COVID-19, further screening rules were adopted for FDIs by Government Decree nr. 227/2020. (V.25.). According to the above, certain transactions concerning Hungarian-seated companies operated in strategic sectors by foreign investors shall be reported to the Minister of Finance and the acknowledgement of the Minister of Finance is necessary for the realisation of the acquisition of the shares until 31 December 2020. These transactions include the acquisition of shares, the increase of the registered capital and the transformation of the company. The strategic sectors specified by the Government Decree include energy, communication, finance, agriculture and food industry, healthcare, construction, transport industry, tourism, IT, mechanical engineering, etc. Those foreign investors that have shares in a company registered in the EU, European economic Community or in Switzerland shall only report the transaction if majority interest will be acquired indirectly. Conversely, the foreign investors wishing to acquire shares in a Hungarian company directly have to report any transactions by which the foreign investor would acquire shares at a ratio of at least 10% and the value of the investment is at least 350 000 000 HUF (appx EUR 1 mln). The Minister of Finance has 45 days or in specific and duly justified cases 60 days to decide on the acknowledgement of the transaction. Should the Minister provide a negative decision, then the exact reason of the prohibition is not required to be mentioned. Aggrieved investor may appeal before The Metropolitan Court for a review of the prohibiting decision.

Banking, agriculture, defence and energy

The Hungarian government has publicly declared that reducing foreign bank market share in the Hungarian financial sector and tightening regulations governing NGOs are key priority areas. Several state-led initiatives over the past several years targeted the banking sector and reduced foreign participation.

1. Year-on-year inflation was 25.2% in March, falling by less than expected from the 25.4% recorded in February, according to Central Statistics Office (KSH). The March inflation figure was above the average forecast of 24.9%. Core inflation – which excludes energy and seasonal foods – rose to 25.7%, up from 25.2% in February, and came to 1.5% month-on-month. Products having the highest price increases were eggs (74.0%), dairy products (72.8%), butter (68.0%) and bread (67.0%). Home energy prices expanded by 43.1%. Within this, the price of pipeline gas went up by 62.8%, firewood cost 55.9% more, the price of cylinder gas rose by 51.6% and electricity cost 27.6% more. Fuel prices alone saw 26.9% growth. Hungary had the highest inflation in the EU more than three times higher than the EU average of 8.3% for the month, according to Eurostat figures. Runner-up Latvia was a distant second, at 17.2%, and the Czech Republic was third, at 16.5%.

2. The IMF significantly lowered its forecast for Hungarian economic growth for 2023 in its latest World Economic Outlook, cutting the estimate to 0.5% from the 1.8% envisaged in October. At the same time, the IMF raised its average inflation forecast for 2023 from 13.3% to 17.7%. According to the IMF, the current account deficit will be 4.6% of GDP this year, contrary to the 4.0% forecast by the MNB, down from 8.1% in 2022.

3. Industrial production was down by 4.6% yr-on-yr in February, the KSH said. Workday-adjusted data also show a 4.6% annual decrease in output in February. Manufacturing output, representing 98% of total production, decreased by 4%. Automotive sector production increased by 7.5%, as car production rose by 4.1% and car parts production grew by 11.6%. Industrial production in the first two months was 2.4% lower than in the same period of last year. Industrial exports, constituting 58% of industrial sales, decreased by 1.1% while domestic sales were down by 14.4% in January-February. The production of electronics increased the most, by 27.9%, as battery production expanded by 47% and electric engine, generator and transformer making went up by 22%.

1. Eximbank has issued **\$1.25** bln in a five-year bond, the Economy Development Ministry, which controls the bank, announced. The proceeds raised from the issue will help provide funds on favourable terms to the domestic entrepreneurial sector in the current unfavourable credit environment, further strengthening its prominent role in the financing of the Hungarian economy, the ministry said.

2. Forint hits 12-month high against euro: The forint has appreciated by 7% against the euro in the past 12 months, having reached 370 on 18 Apr for the first time since last spring. Analysts forecast an exchange rate of Ft 380-400 per euro at the end of the year. The forint has also gained more ground against the dollar than any other currency since January 1, rising by 9.5% in value.

3. Food price caps extended, gov't to introduce price monitoring: Government has extended the price caps on specified food items to June 30 as part of its fight against inflation, and these prices will continue to be monitored in the major food store chains. Products in supermarkets and department stores will be divided into 20 categories and one product in each category must be offered for sale at a price 10% lower than the lowest price in the previous 30 days. This may not apply to products offered at capped prices. The regulation model follows Greek and French examples. In addition, the cabinet's ban on imports of grain and certain other agricultural produce from Ukraine will also continue until June 30. Ukrainian agricultural produce destined for third countries may transit Hungary and it will be possible to monitor such shipments across the country to ensure that deliveries are not made within the country.

4. Wage growth at **19.6%** in February: The average gross wage of full-time employees was Ft 531,200 (appx EUR 1,436) a month in February, up by 0.8% from one year earlier, but real wages dived by 19.6% as inflation stood at 25.4%, the KSH said. The average net wage was Ft 353,200 (appx EUR 955), also increasing by 0.8% yr-on-yr. It is

pointed out that the data are distorted as the figure for February 2022 was artificially high, due to the payment of the "service premium" (the so-called "gun money") for army and law enforcement personnel corresponding to six-month's salary. With the effects of this filtered out, the figures reveal growth of 14.8% in gross wages and 15.2% in net wages.

5. Hungary has reached new agreements with Russia that ensure smooth and continued natural gas and crude oil supplies for Hungary in the near future, Foreign Minister Peter Szijjarto said after a meeting on 11 Apr with Deputy Prime Minister for Energy Affairs Aleksandr Novak. He said it is fundamentally important that Russian gas shipments should proceed without any problems, as Hungary gets 80-85% of its gas from Russia.





Tariff and Non-Tariff Barriers to Trade:

import Tariffs: The tariff rate on imports averages a comparatively low 1.1% of the value of goods (for international trade), which is the lowest figure regionally and third lowest figure in the whole emerging Europe region. Bosnia's import tariffs are harmonised each year with the combined nomenclature of EU and legislative regulations.

Anti-dumping and countervailing duties: in 2009 Bosnia introduced a law for the protection of domestic products against imports from Croatia and Serbia.

The law stipulates that safeguard measures were necessary owing to the influx of imports and the dumping of particular agricultural products from Croatia and Serbia, as well as a conceivable decrease in exports from Bosnia to Serbia.

Customs and Non-tariff Barriers: as a result of BiH not having EU member status event though the majority of its trading partners are EU member states, export and import supply chains will face more onerous border and documentary times and costs when compared with those of EU states.

The most salient risk is the high cost associated with import border compliance processes, which is higher than that of countries such as North Macedonia and contributes towards Bosnia's status as regional under performer in relation to customs burdens.

Businesses operating in BiH face a high import burden as infrastructural development, industrial capacity and diversification remains weak because of a dearth of fixed capital formation and a lack of political resolve in the country. Imports are driven by the country's need for complex machinery and its energy requirements, such as oil and gas, as well as metals and manufactured goods that cannot be produced locally.

To spur trade, Bosnia has exempted tariff payments from certain equipment that is being imported as part of share capital, with the exceptions of passenger vehicles and slot or gambling machines. To enjoy this benefit, foreign investors must submit a written request to the appropriate customs authority, along with evidence of the investment arrangement and registration of the foreign share. Alternatively, imports into one of Bosnia's four free trade zones are exempt from customs duties and fees. These zones can be found at Vogosca, Visoko, Mostar and Holc Lukavac and clearly mitigate cost risks for businesses seeking to trade internationally with Bosnia. Bosnia has applied to join the EU, and accession would open up trade, investment and growth opportunities for the economy. The country has already made good strides in establishing free trade and preliminary agreements to speed up the process of EU accession although, political instability threatens the prospect of EU membership in the medium term. Bosnia is also currently discussing the possibility of the creation of a Western Balkans Customs union with its South eastern-Europe counterparts.

Average net salary in BiH is KM 1,211 (EUR 619.2): The average monthly paid net salary of employees in Bosnia and Herzegovina in February 2023 was 1,211 (EUR 619.2) convertible marks which is nominally higher by 14.4% yr-on-yr. For the same period, the real index was 1.3%. The highest average net salaries in February 2023 were those employed in financial and insurance activities KM 1,772 (EUR 906) followed by information and communication activities KM 1,731 (EUR 885), and in the production and supply of electricity, gas, with steam and air conditioning KM 1,705 (EUR.871) Workers in the provision of accommodation, food preparation and service had the lowest average net earnings, KM 811 (EUR 450), and in construction, KM 884 (EUR 452). The average monthly gross salary in BiH in February amounted to KM 1,863 (EUR 952.5),

Inflation is slowing down: According to the Central Bank of Bosnia and Herzegovina (CBBH) inflation can be expected to slow down this year, which stood at 12.9% in February. According to November 2022 date, inflation was forecast at 6.3% in 2023, or 3% in 2024. Currently inflation is estimated to stand at 12.6% in the first quarter of this year and at 8.6% in the first half of the year with price pressure on energy and food to be expected to be lower.

Industry decline on an annual basis in FBiH

seasonally adjusted industrial production in the Federation of Bosnia and Herzegovina (FBiH) in March compared to February 2023 was higher by 1.3%, while compared to March 2022 it was lower by 4.9%.%. On an annual level, in March 2023, yr-on-yr, Production and supply of electricity and gas increased by 0.4% and

dropped by 6.7% in ore and stone extraction and decreased by 5.8% in the manufacturing industry, according to data from the Federal Bureau of Statistics.

BiH countersigns Financing Agreement for EUR 70 mln EU Energy Support Package: At a ceremony in Sarajevo on 04 Apr, the Chair of the Council of Ministers of Bosnia and Herzegovina Borjana Kristo handed over the countersigned Financing Agreement for the EU Energy Support package to the Head of the EU Delegation and EU Special Representative in BiH, Ambassador Johann Sattler. The European Commission will therefore soon disburse the first instalment (90%) of the EUR 70 mln package, which will provide assistance to the most vulnerable households to cope with rising prices as well as support energy transition. This is the first time that BiH authorities have received support to be distributed to the public in this way. As the country advances on the EU path, authorities will need to demonstrate that they have the capacity to implement the significant resources that BiH will be entitled to as an EU member. . Of the EUR 70 mln allocated in immediate assistance, EUR 50 mln has been allocated to support vulnerable

households, and 20 mln to support energy efficiency efforts. The Energy Support Package for the Western Balkans was announced at the end of October 2022 by the European Commission President Ursula von der Leyen at the beginning of her visit to the region. The overall package is worth EUR 1 bln in grants with EUR 500 mln allocated as immediate assistance for the region.

Negative risks for Bosnia and Herzegovina are high: According to IMF projections, inflation in BiH will fall to 6% this year from 14% in 2022, in line with the rapid drop in food and fuel prices on the international market. Base inflation is expected decline more slowly, with economic growth to decrease in 2023 to 2% from the 3.8% in 2022, as a result of weaker domestic demand, as well as weaker demand for exports overall economic trends in BiH depend on the political situation, but also on the trends in the markets of neighboring countries. Negative risks are high and include the intensification of internal political tensions, the slowdown in Europe, and the realization of financial risks. The year ended with a surplus and in such years there is no need for an IMF arrangement. The current rating of BIH is a stable B+.

Success of companies in the field of defence industry: Defence manufacturers continued their successful operations on foreign markets in the first quarter of 2023. The Foreign Trade Chamber of Bosnia and Herzegovina said that in the Q1, weapons, ammunition and their accessories and parts worth KM 51.5 mln (EUR 26.1 mln) were exported, which represents an increase of KM 10.5 mln (EUR 10.5 mln). As confirmed, similar trends apply to explosives and pyrotechnic products. According to the Chamber of Foreign Trade, export of weapons, ammunition and their accessories and Arabia KM 15.2 mln (EUR 7.8 mln), the USA KM

12.3 mln (EUR 6.3 mln), Turkey KM 9.3 mln, (EUR 4.8 mln), Angola KM 3.3 mln (EUR 1.7 mln), and Germany KM 2.5 mln (EUR 1.3 mln).
