Economy:

1. West Sumatra's Export Value in February 2023 Increases, India's Biggest Destination

Padang, (Sumatra):

The Central Statistics Agency (BPS) recorded the export value from West Sumatra Province in February 2023 amounting to US\$222.44

million, an increase of 34.43 percent compared to January 2023 exports of US\$165.47 million. West Sumatra BPS Head Herum Fajarwati said on Wednesday (5/3) that however, when viewed in the same period the previous year, exports from West Sumatra in February 2023 fell by 11.38 percent. Herum said exports from West Sumatra to India had the largest role in total exports of W Sumatra in January-February 2023, namely 26.17 percent.

2. Apple to Open First Authorized Retail Store in India Mumbai, (Antara):

OPEC's market share of India's oil fell at the fastest pace in 2022/23 to its lowest level in at least 22 years. This is due to the increasing intake of cheaper Russian oil. Members of the Organization of the Petroleum Exporting Countries (OPEC), mainly from the Middle East and Africa,

11. ISMA: India's Sugar Production Could Drop to 32.8 Million Tons New Delhi, (Antara):

India is likely to produce 32.8 million tonnes of sugar in the 2022-2023 marketing year, down 3.5 per cent from the previous forecast, as sugarcane yields in key producing states fall due to erratic weather conditions, a leading trade body said in Wednesday (26/4). Aditya Jhunjhunwala, president of the Indian Sugar Mills Association (ISMA) said lower sugar output could limit exports from the world's second-biggest exporter, lift global prices and allow rivals Brazil and Thailand to increase their shipments.
