During the calendar year 2022, both exports and imports from/to India have registered a healthy growth via-a-vis the corresponding period last year 2021. Figures show a new record of exports in the current calendar year 2022 from USD 1080 million in CY 2021 to USD 1395 million in CY 2022, registering a growth of 29.16%. In the same period the imports to India rose from USD 1825 million USD in CY 2021 to USD 2728 million USD, registering a growth of 49.5%. India imports a large number of phosphates, fertilizers and derivatives, whose prices have increased significantly in year 2022.

In the current financial year, while demand for engineering goods, petroleum and agri commodities remained strong, there has been some demand slow down in chemicals, pharma and electronic goods. The first meeting of the Joint Working Group on Fertilizers took place on March 10, 2023 during which Indian side and OCP discussed ways and means to further elaborate bilateral cooperation in the fertilizer *sector*.

Mission is in constant touch with the Foreign Office and following up with Indian counterparts on a number of issues discussed in last Joint Commission Meeting as well as follow up on joint committee/joint working groups on a number of area including health, agriculture, water resources, mines & minerals among others. Mission is also pursuing for holding the first Joint Working Group meeting on tariff and non tariff barriers etc.

Bilateral

(I) First meeting of the JWG on Fertilizer :

The first meeting of the Joint Working Group between India and OCP was held virtually on March 10, 2023. The Indian side was led by Ms Neerja Adhidham, Additional Secretary while Moroccan side was led by Mr Soufyane ElKassi head of SBU and CEO of Nutricorp Ltd(a subsidiary of OCP). Both sides discussed on a range of issues, including strategic reserves, preferntial pricing, R&D cooperation and customised fertilizer and also discussed investment from both sides to strengthen relations between two countries in the field of fertilizers.

(II) India Morocco Business Conference

Embassy of India in association with Casablanca-Settat Chamber of Commerce, Industry & services organized India-Morocco Business Conference on March 1, 2023 in Hotel Marriott Casablanca. The event was addressed by Ambassador Rajesh Vaishnaw and President of Chamber Mr. Hassan Berkani. There were interesting presentations by business leaders from both countries which further provided an opportunity to strengthen India Morocco trade relations in different sectors (pharmaceutical industry, Information Technologies, Tourism, etc.). The conference was well attended by prominent companies and businesses from Morocco and India as well as many Moroccan officials from different Moroccan administrations (customs etc.), federations and associations,

(III) Bilateral Cooperation in Digital Payment:

Official from National Payments Corporation of India (NPCI) met officials from Bank Al-Magrib in the month of March 2023 and discussed proposal for developing a real-time payment system in Morocco and sharing India's experience of achieving financial inclusion through UPI platform. Moroccan side is keen to have a digital payment solutions and is in constant touch with NPCIL to have a country specific payment solution gateway like UPI and RuPay.

Macro economic indicators

(I) Agriculture: EU's Wheat Exports to Morocco Hit Record High

The United Nations' Food and Agriculture Organization's quartly report showed that Morocco recorded the largest decrease in cereal production in North Africa in 2022. Morocco's output was estimated at nearly 3.3 million tonnes, a sharp 60% decrease from the average of 8.5 million tonne in 2021, due to the drought that the country experienced in 2022.

In the 2022/2023 agriculture season, Morocco has become the biggest importer of wheat from the European Union amid declining supplies from eastern Europe and the 2022 drought. According to data Morocco is set to import 1.5 million tonnes of soft wheat between March and May 2023.

(II) Tourism Revenues to Reach Record \$10 Billion in 2023

The Minister of Tourism, Handicrafts, and Social Economy, Fatim-Zahra Ammor, has said that new roadmap of tourism 2023-2026 has put tourism at the heart of national priorities and aims to double the number of arrivals to 26 million tourists by 2030. The country's tourism revenues expected to cross the MAD 100 billion (\$10 Billion) threshold in 2023. The Minister has informed that the government was working on nine major projects to meet the rising demand from tourists. Apart from this, it was also informed that the Government has decided to allocate funding of MAD 6 Billion (\$578,3 million) in next few yearss. The roadmap aims to attract 17.5 million tourists, generate MAD 120 Billion (\$11,5 billion) in receipts and create 200,000 new jobs by 2026. It may be noted that Moroccan economy depends a lot on tourism sector and tourist arrivals have just reached to pre-covid level in year 2023.

(III) Morocco Requests \$5 Billion Credit Line from IMF

The International Monetary Fund (IMF) has announced this month that its executive board has received from Morocco a \$5 billion credit line request. It is worthy to note that Morocco, after removal from the FATF Frey List, has made serious efforts to secure loans and credits from the international agencies to bridge its trade deficit which is attributed to high energy prices and food import bill.

Apart from that World Bank has also agreed to provide support of USD 250 million to education reforms in the country. The amount is aimed at capacity building at pre school and other areas related to elementary education in the country.

(IV) Consumer Prices in Morocco Continued to Rise in February

Morocco's Consumer Price Index (CPI) —the indicator used to measure national inflation — rose in February 2023, reflecting growing consumer goods prices. Morocco's High Commission for Planning stated that in February, the CPI rose by 1.7% compared to the month before, and by 10.1% year-on-year.

However, the Central Bank of Morocco in its reporthas indicated that the inflation may moderate in 2023 after reacghing record levels in 2022 at 6.6%,. The Central Bank expects average inflation in 2023 at 5.5 %. Following their first quarterly meeting in 2023, BAM announced raising interest rates

for the third time within less than two years, a first since 2006. BAM issued a statement explaining that the board "decided to raise the policy rate by 50 basis points to 3% in order to prevent the onset of self-sustaining inflationary spirals and to avoid the risk of a fall in the price of food."

(V) Morocco Launches Construction Work of First Lab for Legal Cannabis Industry

Bio Cannat, the first Moroccan cooperative authorized to market and export cannabis and its products for industrial and medical use, launched the construction work for its first laboratory. It may be noted that the Morocco, after a lot of discussion has permitted use of cannabis in various therepeatic purposes.

Morocco- External

i. British Government Studies Viability of Morocco-UK Xlinks Power Project

The UK government issued a policy paper announcing that it was considering the viability of the Xlinks Morocco-UK Power Project and studying how it could contribute to the country's energy security. Xlinks poer project is aimed at connected power grid connectivity between UK and Morocco through undersea power cable.

ii. Morocco importing diesel from Russia

Morocco's government acknowledged there has been a noted increase in Russian gas exports to Morocco. The country, amid the EU sanction, has been increasing impring the diesel and petroleum in order to meet the domestic demand. There has been some controversy as well regarding the pricing on which imports are being made by the companies and the price on which it being sold to public, making super normal profits.

iii. Morocco, Cambodia to Expand Cooperation, Sign Air Connectivity Agreement

The Minister of Foreign Affairs, African Cooperation and Moroccan Expatriates, Mr. Nasser Bourita, and the Secretary of State for Civil Aviation of the Kingdom of Cambodia, Mr. Mao Havanall, on March 27, 2023 in Rabat, signed an agreement on the promotion of the aviation system between the two countries.

Iv. Queen Maxima of the Netherlands in Morocco to Promote Digital Financial Inclusion

Queen Maxima of the Netherlands was on a working visit to Morocco to promote fintech, the development of digital payment systems and inclusive green finance, among other key financial inclusion issues. Throughout her working visit, she examined how Morocco's fintech sector could progress, including support for technology that could help address risks, costs, and geographic barriers to financial services in Morocco.

OCP, Fertilizer and Phosphate news

i. Morocco's OCP Records \$11 Billion Turnover in 2022 and to Pay \$750 Million Dividends to Government

Morocco's state-owned phosphate giant OCP Group recorded an annual turnover of more than MAD 114.57 billion (\$11 billion) in 2022, marking a 36% year-on-year increase. Despite of the low output volume, the company has clocked record turnover due to very high prices of phosphate and fertilizer.

OCP Group has also announced that it will pay \$750 million in dividends to the Moroccan government.

Companies

i. Dacia to Manufacture its First Hybrid Car in Morocco

The car manufacturer Renault Group unveiled its first hybrid model "Dacia Jogger" and announced plans to launch production at its Tangier plant in northern Morocco in the second quarter of 2024. The new line of production is expected to produce up to 120,000 vehicles and marks a precedent for Morocco in the manufacturing of hybrid cars. Converging reports indicate that the production is set to use thirty robots for assembly operations.

ii. Automotive Supplier Aptive Inaugurates New Plant in Morocco's Oujda

American-Irish automotive supplier Aptiv inaugurated a new production plant in Oujda. With the new opening, the company now has seven factories in Morocco. Located in the Oujda's industrial zone, the plant will specialize in the assembly of electrical harnesses and is set to generate 3,000 direct jobs, according to converging news reports.

iii. Elcora Begins Manganese Mining Operations in Morocco

Canada-based mining company Elcora announced the commencing of Manganese extraction operations in a 16-square-kilometer concession in northern Morocco. In a statement, Elcora mentioned that the already extracted Manganese piles onsite contain about 5,500 metric tonnes of Manganese ore. "This allows Elcora to sort, process and sell manganese ore as of today in order to meet customers' expectations," the company stated.

iv. Morocco Receives First Heavy Electric Truck in Africa

Swedish car manufacturer Volvo delivered its first heavy electric truck to Morocco. The vehicle marks the first heavy battery-electric truck from a global manufacturer to be in commercial operation in Africa. The electric truck will be used for collecting waste and will replace the existing Volvo FE diesel truck. The new vehicle will save approximately 30 tonnes of CO2 emissions each year, according to a statement from Volvo.

v. Energy Company TAQA to Invest \$1.6 Billion Into Morocco's Green Future

Subsidiary of Abu Dhabi National Energy Company TAQA has announced that it will invest \$1.6 billion in the country's green energy projects by 2030, as per the media reports. One of the projects includes creating a seawater desalination facility to help resolve water supply issues.
