



## Online Q & A Session on the Judgment by Hon'ble Supreme Court on DAUGHTERS HAVE EQUAL BIRTHRIGHT TO INHERIT PROPERTY

## Dear Sir / Madam,

The Apex Court of India passed a widely reported landmark Judgement on 11<sup>th</sup> August 2020 stating that daughters, like sons, have equal birthright to inherit joint Hindu Family property. The Hon'ble Court further ruled that the amended Hindu Succession Act, which gives daughters equal rights to ancestral property, will have a retrospective effect which confers the status of 'Coparcener' to a daughter born before or after the amendment in the said act in the same manner as a son.

In this context and to enable public to seek more clarity on the Verdict; a joint Session of Questions & Answers (Q & A) is being organised by the IMC Law Committee in association with Ladies Wing of IMC.
