He has Mediation experience spanning over two decades and conducts basic and advanced workshops for training mediators.

He is an empanelled Mediator at several institutions, including the Bombay High Court (since 2003) and has mediated a range of disputes referred to him directly as well as by various courts. He regularly trains professionals, students and others in the art of Mediation & Conciliation. He has authored several articles on Mediation, has contributed to several international publications and is the author of the Monograph Series publication of the CTC (Chamber of Tax Consultants) on the topic of *Mediation & Conciliation*.



Mediation is an art as well as a scientific process. The success of the Mediation process depends upon the ability and skill of the Mediator in collaboratively engaging the parties in this process so as to create an environment that encourages a meaningful dialogue focused on understanding each other.

The intent and content of this workshop is to give the Participants an opportunity to hone some of the skills introduced to them in the Basic training, supported by fresher perspectives, through presentations and exercises. This workshop would also be a good opportunity, time-permitting, for participants to seek pointers to address some of the issues faced by them in their mediations.

The Workshop will start with a Refresher of some of the essential skills required in a mediation process and will then proceed towards an engaging conversation surrounding two selected skill-sets.
