The Consumer Protection Act, 2019 received the assent of the President of India and was published in the official gazette on 9<sup>th</sup> August 2019. New Consumer Protection Act replaced the 34 years old act and came into effect from July 20, 2020.

It is a law to protect the interests of the consumers. This act is inevitable to resolve a large number of pending consumer complaints in consumer courts across the country. It has ways and means to solve the consumer grievances speedily and to save the rights of the consumers by establishing authorities for timely and effective administration and settlement of consumers' disputes.
