 website of the Chamber and also on the Service Provider to facilitate its Members to cast their
 vote through Remote E-Voting.
- The Cut-off date for the purposes of identifying the Members who were entitled to vote on the resolutions placed for approval of the Members was 6th July 2023.
- The Remote E-Voting facility was open from Saturday, 1st July 2023 at 9.00 A.M. to Thursday, 6th July 2023 at 5:00 P.M.
- At the venue of the AGM of the Chamber, the facility to vote through Ballot Form was provided to facilitate those Members present at the meeting but could not participate and cast their votes by availing the Remote E-voting facility.
- The Chairman, at the end of the discussion on the resolutions on which voting were to be held in physical mode, allowed voting by ballot form for all those Members who were present at the AGM but could not cast their votes through remote e-voting facility.
