- 11. **Trade Policy development (TBT/SPS/Anti dumping etc.):** (1) In the wake of depleting forex reserves in the country and widening trade deficit, the Royal Government of Bhutan on 18 August 2022 decided to impose a moratorium, suspending the import of "non-essential' vehicles, which is currently in force till 18 August 2023.
- (2) Bhutan Government has banned the conduct of consumer trade fairs and general fairs that involve external parties and imported goods with effect from 23.12.2022. Only thematic fairs meant for promoting local goods and services and for export purposes will be allowed with prior approval from the government.
- (3) Import of live pigs and pork products into Bhutan has been banned w.e.f. 27 July 2022 to prevent introduction of African Swine Fever (ASF). Based on request from APEDA, Mission has been following up with Bhutan government authorities to permit import of pork products from M/s Mayur Piggery Farm located in Pune, along with documentary evidence to prove that there are no reports of ASF in pigs from M/s Mayur Piggery Farm.

INTERNAL

1. BUDGET FY 2023-24 – HIGHLIGHTS:

a. Economic Outlook

- The economy exhibited a growth of 4.1 percent in 2021, an increase of 14.1 percentage points compared to the contraction of 10.1 percent in 2020.
- The economy is poised for a gradual recovery buoyed by stronger domestic demand, continued fiscal and monetary relief measures, opening up of borders, and normalization of economic activities. As such, the economic growth is estimated to accelerate to 4.7 percent in 2022.
- The FY 2023-24 budget is aimed at 'Building stronger institutions through strategic reforms while ensuring a sustainable fiscal path and smooth transition'.

b. Resources

- The total estimated resource for FY 2023-24 is Nu. 53,513.2 million, a decrease of 12.4 percent from the FY 2022-23 revised resources estimate.
- The total estimated domestic revenue of Nu. 46,245.8 million for FY 2023-24 is inclusive of Nu. 4,000 million being transferred from the DHI.
- The domestic revenue excluding the transfer from DHI is estimated at Nu. 42,245.8 million, which is an increase of 3.5 percent from the previous FY.
- The estimated external grants of Nu. 6,367.4 million consists of Nu. 2,320.1 million from GoI, Nu.1,743 million from ADB, Nu. 401.2 million from World Bank and remaining from other development partners.

c. Expenditure

- Total expenditure is estimated at Nu. 74,861.6 million of which recurrent allocation is Nu. 45,545.9 million and capital allocation is Nu. 29,315.7 million which constitutes 60.8 percent and 39.2 percent of the total expenditure respectively.
- Of the total capital expenditure, about 27 percent is financed through internal/external grants, and 73 percent from external/internal borrowings.

d. Debt Situation Outlook

As of 31st March 2023, the total public debt stood at Nu. 267,401.3 mil-lion, accounting for 132.1 percent of FY 2022-23 GDP estimate. »The total public debt comprised Nu. 240,851.3 million (119 percent of GDP) of the external debt stock and Nu. 26,550 million (13.1 percent of GDP) of the domestic debt stock.

2. 22.06.2023: Druk Green Power Corporation (DGPC) generated 10,752.23 MU of electricity in 2022, with 3,294.73 MU consumed domestically and 7,819.40 MU exported to India. Mangdechhu Hydropower Plant earned Nu.12,541.6 million, with bi-annual repayments and interest payments of Nu.6,962.510 and Nu. 5,033.8 million, respectively.

- 3. 22.06.2023: A total of eight FDI projects worth Nu. 356.3 million were approved in the year 2022 indicating a decline by Nu. 357 million. As of December 2022, the country saw a total of 101 FDI projects worth Nu. 4,362 million. The hospitality sector constitutes 36 percent of these FDI projects followed by IT/ITES at 22 percent. Investments from Asia remain at the top with 67 percent followed by 16 percent from Europe. Within Asia, 51 percent of the projects in the country are from India followed by Singapore at 15 percent and Thailand at 10 percent.
- 4. 22.06.2023: The economic downturn led to unprecedented unemployment rates, reaching 5.9% in 2022, 1.1 percentage points higher than 2021. The increase is attributable to a greater number of people entering the job market, mis-match of skills, and scarcity of work opportunities. Similarly, the youth unemployment rate increased to 28.6 percent in 2022 compared to 20.9 percent in 2021.
- 5. During the year 2022, SOEs (State Owned Enterprise) contributed Nu. 245.5 million in the form of tax and dividends. The tax contribution decreased to Nu. 92.5 million as compared to Nu. 201 million in 2021 which is attributed to the losses incurred by 9 SOEs. However, the dividend contribution increased from Nu.110 million in 2021 to Nu.153 million in 2022 due to improved revenue performance of Bhutan Lottery Limited and Bhutan Duty Free Limited. As of December 2022, the combined net asset of SOEs stands at Nu. 8,480 million, a decrease of 10 percent as compared to the previous year.
- 6. 03.06.2023: Bhutan's 1999 plastic bag ban marked a significant step towards eradicating plastic waste. Despite subsequent reinforcement measures in 2005 and 2009, the ban's effectiveness has been questioned. The latest attempt to reinforce the ban in 2019 has not significantly reduced plastic bag sales.
- 8. 19.06.2023: The country generated about USD 16 Million as sustainable development fees since the reopening of the country for tourism in September of last year. Over the past eight months, Bhutan received more than 52,000 tourists. From over 52,000 tourists, more than 32,500 are Indian tourists who paid Nu 1,200 per night. Similarly, from over 19,000 international tourists, a little over half of them entered the country under the new SDF.
- 9. 06.06.2023: Hydropower export revenue dropped by over Nu 1.5bn in the first four months of the year compared to the same period last year. According to the Royal Monetary Authority's monthly statistical bulletin for May, Bhutan exported over two billion ngultrum's worth of electricity from January to April last year, while the number dropped to about Nu 400 M this year. The Druk Green Power Corporation attributes the drop in revenue to the country receiving less snowfall and decreased river flow.
- 10. The Bhutan Chamber of Commerce and Industry (BCCI) organized the "Bhutan Thematic Expo 2023" from 22-26 June 2023 at the Changlimithang Parking Space, Thimphu. The five-day expo featured eight thematic segments inorder to promote local entrepreneurship, facilitate product promotion, and foster networking opportunities. The event brought together 61 participants. Azista Bhutan Health Care Limited (ABHL), a joint venture company between Druk Holding and Investment InnoTech, Bhutan, and Azista Industries Private Limited, India, showcased their range of pharmaceutical drugs.
- 11. 17.06.2023: Starting April 1, 2023, oil companies are selling fuel to Bhutan at the same rate as Nepal, resulting in lower prices for petrol and diesel. This is achieved through lower prices, removal of bulk charges, and a slight dip in oil prices. As of June 16, petrol prices in Thimphu are Nu 66.05 per liter and diesel Nu 64.24 per liter.
- 12. The price of consumer goods and services increased by 3.40 percent in May 2023 compared to the same month last year. The prices increased for both food and non-food by 3.22 percent and 3.57 percent respectively.

Month-on-month CPI in May 2023 decreased by 0.39 percent from April 2023, with decrease in both food and non-food prices. The prices for food and non-food decreased by 0.39 percent and 0.54 percent respectively.
