Since Indian Customs did not respond to two requests, according to the Agreement that India signed with the EU, it is understood that preferential origin has not been proven, and therefore the said goods are subject to customs duties, interest and a penalty for ACG Europe because the goods were improperly declared. 			<p>addition, all goods for the past three years may be subject to verification of preferential origin, which would bring additional problems and costs for ACG Europe if Indian Customs does not respond again.</p> <p>Besides this, the company is facing a problem obtaining a veterinary certificate for their bovine gelatin-based Hard Gelatin Capsule Shells to export to India. The certification process requires approval from both the Croatian Ministry of Agriculture and the Indian Ministry of Fisheries, Animal Husbandry &amp; Dairying. However, due to the lack of a trade agreement between Croatia and India, the Indian ministry has not approved the final format of the certificate. #### IV. Any other submission

##### **1. GDP increased in real terms by 3.7% in the fourth quarter of 2024, as compared to the same quarter of 2023.**

In the fourth quarter of 2024, GDP increased in real terms by 3.7%, as compared to the same quarter of 2023. The first estimate shows that the quarterly gross value added (GVA) increased in real terms by 3.5% in the fourth quarter of 2024, as compared to the same quarter of 2023, based on non-adjusted data. The quarterly increase in GVA is visible in all activity sections and it was mainly influenced by Wholesale and retail trade, Transportation and storage, Accommodation and food service activities and Construction. Household consumption increased in real terms by 6.3 % in the fourth quarter of 2024, mainly due to an increase in turnover from retail trade. Government spending increased by 7.1% in real terms in the fourth quarter of 2024, as compared to the same period of the previous year. In the fourth quarter of 2024, the export of goods and services increased by 4.7% in real terms, while the import of goods and services by 9.9% in real terms. (Source: Croatian Bureau of Statistics)

##### **2. The prices in January 2025 increased by 4.0% at the annual level.**

In January 2025 compared to January 2024 (at the annual level), the prices of goods and services for personal consumption, measured by the consumer price index, increased by 4.0% on average, while, compared to December 2024 (at the monthly level), they increased by 0.1% on average. Observing the main divisions of the ECOICOP classification, at the annual level, the highest increase on average in consumer prices was recorded in the following divisions: Restaurants and hotels, of 9.7% (contribution to the growth of +0.50 percentage points), Miscellaneous goods and services, of 7.5% (+0.47 percentage points), Recreation and culture, of 5.8% (+0.30 percentage points), Education, of 5.4% (+0.04 percentage points), Food and non-alcoholic beverages, of 5.1% (+1.36 percentage points), Health, of 4.5% (+0.14 percentage points), Housing, water, electricity, gas and other fuels, of 4.2% (+0.71 percentage points), Alcoholic beverages and tobacco, of 3.9% (+0.19 percentage points), and Transport, of 3.0%, (+0.41 percentage points). The increase in prices at the annual level was alleviated by a decrease in the prices in the divisions of Communication, of -1.9% (contribution to the decrease of -0.10 percentage points) and Clothing and footwear, of -1.7% (-0.11 percentage points). In January 2025, the prices of goods and services for personal consumption, measured by the harmonised index of consumer prices, increased by 5.0% on average compared to January 2024 (at the annual level) and by 0.2% on average compared to December 2024 (at the monthly level). ##### **3. Average net earnings amounted to 1 361 euro in December 2024.**

The average monthly paid net earnings per person in paid employment in legal entities in the Republic of Croatia for December 2024 amounted to 1 361 euro, which represented a nominal decrease of 0.4% and a real one of 0.5%, as compared to November 2024. The average monthly gross earnings per person in paid employment in legal entities in the Republic of Croatia for December 2024 amounted to 1 877 euro, which represented a nominal decrease of 1.2% and a real one of 1.3%, as compared to November 2024. The highest average monthly paid net earnings per person in paid employment in legal entities for December 2024 were paid in the activity Manufacture of coke and refined petroleum products and amounted to 2 562 euro, while the lowest earnings were paid in the activity Manufacture of wearing apparel and amounted to 846 euro. The highest average monthly gross earnings per person in paid employment in legal entities for December 2024 were paid in the activity Manufacture of coke and refined petroleum products and amounted to 3 885 euro, while the lowest earnings were paid in the activity Manufacture of wearing apparel and amounted to

1 082 euro. The average monthly paid net earnings per person in paid employment in legal entities in the Republic of Croatia for December 2024 were 14.3% higher in nominal terms and 10.5% higher in real terms, as compared to the same month of the previous year. The average monthly gross earnings per person in paid employment in legal entities in the Republic of Croatia for December 2024 were 15.9% higher in nominal terms and 12.1% higher in real terms, as compared to the same month of the previous year. Median net earnings for December 2024 amounted to 1 156 euro, which was 0.5% lower than in November 2024. As compared to the same month of the previous year, they increased by 15.0%. Median gross earnings for December 2024 amounted to 1 559 euro, which was 1.2% lower than in November 2024. As compared to the same month of the previous year, they increased by 16.9%. **4. There were 5.4% more tourist arrivals and 4.9% more tourist nights in December 2024 than in December 2023.**

In December 2024, there were 410 thousand tourist arrivals and 880 thousand tourist nights in commercial accommodation establishments, which was an increase in arrivals of 5.4% and in nights of 4.9% compared to December 2023. Domestic tourists realised 172 thousand arrivals and 318 thousand nights, which was 6.8% more arrivals and 5.1% more nights compared to December 2023. Foreign tourists realised 238 thousand arrivals and 562 thousand nights, which was 4.4% more arrivals and 4.8% more nights compared to December 2023. The most foreign tourist nights in December 2024 were realised by tourists from Slovenia, as much as 94 thousand nights, which accounted for 16.7% of the total realised foreign tourist nights. These were followed by tourists from Austria (14.8%), Germany (12.9%), Italy (7.7%), Bosnia and Herzegovina (5.4%), Serbia (3.7%), the USA (3.4%) and Hungary (2.9%). The most tourist nights in December 2024 were realised in the City of Zagreb, as much as 239 thousand of them, which accounted for 27.2% of the total tourist nights realised in Croatia. Compared to December 2023, there were 2.2% more tourist nights realised in the City of Zagreb. The County of Primorje-Gorski kotar and the County of Istria followed, with 152 thousand and 150 thousand realised tourist nights, respectively. Both counties realised an increase in tourist nights in December 2024, as compared to December 2023. (Source: Croatian Bureau of Statistics).

## f) Sectoral insight from Croatia

### Croatia – Pharmaceuticals Report 2025

#### Key View

In the long term, Croatia's pharmaceutical market is anticipated to see moderate growth, driven by an ageing population, increasing burden of chronic diseases and a gradual rise in healthcare expenditure. However, pharmaceutical sales are forecast to see a steady uptick, further supported by the government's ongoing efforts to improving healthcare infrastructure and accessibility. Although the market's expansion offers potential for increased revenue, persisting issues, including corruption

and stringent pricing controls, continue to pose challenges. Through to 2029, the pharmaceutical market in Croatia will see high-single digit percentage growth.

### **Pharmaceutical Market Forecast**

In the short term, high levels of inflation will continue to influence pharmaceutical market trends in Croatia. Through to 2034, Fitch expects the pharmaceutical market to grow at a steady pace. Croatia's challenges such as a small population combined with cost-containment measures continue to hinder market growth, but the ageing population and increasing disease burden may create new opportunities for drugmakers.

In 2024, the Croatian pharmaceutical market expanded by 7.6% y-o-y in local currency terms, reaching EUR2.0bn (USD2.2bn). Pharmaceutical expenditure maintained its share of GDP at 2.4%, consistent with the previous year's figure. On a per capita basis, spending reached USD546, surpassing the investment levels in neighbouring markets. Pharmaceuticals accounted for 35.2% of total healthcare expenditure, thus highlighting it as a focal point for cost-efficiency measures. For 2025, Fitch forecasts 7.5% growth in the market in local currency terms, with an anticipated market value of EUR2.2bn (USD2.3bn). Over the period from 2025 to 2029, Fitch forecasts a compound annual growth rate (CAGR) of 7.2% in local currency terms and 5.7% in US dollar terms. Overall pharmaceutical sales will reach EUR2.9bn (USD2.9bn) in 2029.

### **Croatia Prescription Drug Market Forecast**

Prescription drugs will continue to dominate the Croatian drug market through to 2034, supported by the robust local production capacity and prevailing health patterns. The ageing population is expected to further stimulate the consumption of prescription medications, while the use of OTC remedies is anticipated to see a relative decline. This can be attributed to the contraction of younger demographics, who traditionally display a tendency to opt for non-prescription drug use.

In 2024, the sales of prescription drugs in Croatia reached EUR1.9bn (USD2.0bn), representing a commanding 93.4% of the total pharmaceutical market revenue. Within this segment, generics constituted 42.7%, while patented drugs comprised the remaining 57.3%. Looking forward, Fitch anticipates that the market share of generics will slightly decrease through to 2034. Through to 2029, Fitch's forecast indicates that prescription drug sales will achieve a compound annual growth rate (CAGR) of 7.1% in local currency terms and 5.5% in US dollar terms, with an anticipated market value of EUR2.6bn (USD2.7bn). Over the decade leading up to 2034, Fitch projects a local currency CAGR of 6.7% (5.9% in US dollar terms) for prescription drug sales, reaching a valuation of EUR3.6bn (USD3.6bn).

### **Patented Drug Market Forecast**

The growing demand for innovative medicines in Croatia, supported by epidemiological and demographic changes will continue to impact the patented drugs market. However, the ongoing challenges, such as difficult economic environment and authorities prioritising the use of cheaper generic medicines, will continue to limit market growth. Through to 2034, Fitch still forecasts high single-digit annual growth rates for the patented drug market segment in nominal terms, but expects real growth rates to be lower. In the five-year period to the end of 2029, Fitch expects the patented medicines market to grow at a compound annual growth rate (CAGR) of 6.9% in local currency terms and 5.4% in US dollar terms, to a value of EUR1.5bn (USD1.5bn). The rate of growth will be higher over the 10-year forecast period through to the end of 2034, forecast at a CAGR of 7.0% in local currency terms and 6.3% in US dollar terms. In 2034, Fitch calculates the patented drugs market to be worth EUR2.1bn (USD2.1bn). These figures will represent 59.1% of prescription sales (compared with 57.3% in 2024) and 54.2% of the total pharmaceutical market (53.5% in 2024).

### **Generic Drug Market Forecast**

Croatian generic drug market is expected to decline as a percentage of total sales through to 2034 but will remain fairly stable through to 2029. Fitch maintains views that downward price pressures will remain in place in both the public and private sectors. Over the five-year period through to the end of 2029, Fitch forecasts growth of the Croatian generic drugs market at a local currency compound annual growth rate (CAGR) of 7.2% (5.7% in US dollar terms). This growth rate will be above those expected for their patented counterparts, as the segment's value rises to EUR1.1bn (USD1.2bn). At the end of 2034, generic drugs sales will account for 40.9% of prescription sales and

37.5% of the total market by value (compared with 42.7% and 39.9% respectively in 2024). Fitch forecasts generic drug sales growing at a CAGR of 6.3% in local currency terms (5.5% in US dollar terms) over the coming 10 years to reach a value of EUR1.5bn (USD1.5bn) in 2034. This will translate in a per capita spend of USD395, compared to USD218 in 2024.

**OTC Medicine Market Forecast**

Through to 2034, natural growth drivers, including increased health consciousness and a wider product selection, will continue to drive solid annual growth within this sector. Nonetheless, the OTC drugs percentage of total sales will remain fairly stable over the coming years. OTC sales are expected to experience a five-year compound annual growth rate (CAGR) of 9.7% in local currency terms and 8.2% in US dollar terms, increasing to EUR210mn (USD212mn) in value in 2029. In 2034, the sector is expected to be worth EUR326mn (USD329mn), posting CAGRs of 9.4% and 8.7% in local currency and US dollar terms respectively. In the same year, OTC sales will account for 8.3% of the total market, up from 6.6% in 2024.

**Trade**

The Croatian pharmaceutical trade deficit is expected to increase over the medium term, from EUR597mn (USD648mn) in 2024 to EUR719mn (USD726mn) in 2029. The leading sources of pharmaceutical imports include Hungary, Germany, Slovenia, South Korea and the Netherlands. Croatia-based exporters typically target other Balkan and Central and Eastern European (CEE) markets as well as the US, Russia, the Commonwealth of Independent States and Western Europe. Sales of imported pharmaceuticals, valued at EUR1.7bn (USD1.8bn) in 2024, are expected to increase by 4.6% y-o-y in local currency terms (5.0% in US dollar terms) to reach EUR1.7bn (USD1.9bn) in 2025. Fitch forecasts imports reaching EUR2.2bn (USD2.2bn) in 2029, posting a compound annual growth rate (CAGR) of 5.3% in local currency terms (3.8% in US dollar terms). In the short term, imports of Covid-19 vaccines and related products may still play a minor role in the market's development, with longer-term drivers being of a more organic nature, such as the ageing population. The value of exported pharmaceuticals reached EUR1.1bn (USD1.2bn) in 2024. In 2025, exports are forecast to increase by 6.2% in local currency terms thus rising by 4.3% y-o-y in US dollar terms to EUR1.2bn (USD1.3bn). Through to the end of 2029, exports will post a local currency CAGR of 6.1% (4.6% in US dollar terms), reaching EUR1.5bn (USD1.5bn) in value.
