Overview of General Barriers to FDI in Hungary:

Regulatory barriers and administrative burden are affecting all sectors but particularly energy, construction, and banking: The overall administrative burden, including start-ups, negatively affects investment decisions. The instability of the regulatory framework, with frequent and unpredictable regulatory changes, creates uncertainty for investors and is hindering both internal investment and FDIs.

The Hungarian government imposes a 100% offset requirement for defined sector investments over HUF 1bln (EUR 2.8 mln). Efficiency of procedures in construction and environmental permits is insufficient; corruption also raises risk for investors. There is no requirement that investors must purchase from local sources, but the EU Rules of origin applies.

Ownership restrictions (all non-EU)

according to the 2014 Land Law, only private Hungarian or EU citizens resident in Hungary with a minimum of three years experience of working in agriculture or holding degree in agriculture can purchase farmland, which is limited to 300 hectares. All others may lease farmland. All farmland purchases must be approved by a local land committee and Hungarian authorities, local farmers and young farmers must be offered a chance to purchase the land first. Up to 1200 hectares for a maximum of 20 years may be leased.

Price controls in consumer facing sectors and others considered to be of strategic importance.

The Hungarian government regulates the prices of certain goods, setting the upper and lower limits to which the private sector must adhere. Sectors include energy, pharmaceuticals. Cuts on regulated utilities prices have put considerable pressure on private utilities companies, decreasing profit margins and adding to an increasingly difficult operating environment.

State intervention in Banking, energy, agriculture, media, telecommunications, and retail sectors.

Since 2012 government has invested in state-owned enterprises with the objective of lessening the participation of foreign-owned competitors, especially in the energy sector. From 1 Jan 2019, the chemical industry, the telecom sector, vehicle construction, metallurgy, optics and electric equipment production, the defence industry, water and sewage management, the financial sector, food industry and agriculture, production of construction materials, state administration, health care, wage management, transport and tourism sectors have been added. Foreign investors in the targeted sectors have expressed concerns that the tax regime has become unpredictable and the additional levies appear to have been aimed against some industries with a high level of foreign ownership.

Basic Rules of The Protection of Strategic assets Concerning Foreign investments

The European Commission has issued Communication 2020/C 99 i/01 in which it has given guidance to the Member States of the EU concerning the protection of Europe's strategic assets from the foreign direct investment, ahead of the application of Regulation (EU) 2019/452 (FDI Screening Regulation) which is applicable from 11 October 2020.Commission Delegated Regulation (EU) 2020/1298 of 13 July 2020 amended the Annex to Regulation (EU) 2019/452.

Hungary first adopted FDI screening mechanisms by act LVII of 2018 for FDIs violating the security interests of the country, then in the economic crisis caused by COVID-19, further screening rules were adopted for FDIs by Government Decree nr. 227/2020. (V.25.). According to the above, certain transactions concerning Hungarian-seated companies operated in strategic sectors by foreign investors shall be reported to the Minister of Finance and the acknowledgement of the Minister of Finance is necessary for the realisation of the acquisition of the shares until 31 December 2020. These transactions include the acquisition of shares, the increase of the registered capital and the transformation of the company. The strategic sectors specified by the Government Decree include energy, communication, finance, agriculture and food industry, healthcare, construction, transport industry, tourism, IT, mechanical engineering, etc. Those foreign investors that have shares in a company registered in the EU, European economic Community or in Switzerland shall only report the transaction if majority interest will be acquired indirectly. Conversely, the foreign investors wishing to acquire shares in a Hungarian company directly have to report any transactions by which the foreign investor would acquire shares at a ratio of at least 10% and the value of the investment is at least 350 000 000 HUF (appx EUR 1 mln). The Minister of Finance has 45 days or in specific and duly justified cases 60 days to decide on the acknowledgement of the transaction. Should the Minister provide a negative decision, then the exact reason of the prohibition is not required to be mentioned. Aggrieved investor may appeal before The Metropolitan Court for a review of the prohibiting decision.

Banking, agriculture, defence and energy

The Hungarian government has publicly declared that reducing foreign bank market share in the Hungarian financial sector and tightening regulations governing NGOs are key priority areas. Several state-led initiatives over the past several years targeted the banking sector and reduced foreign participation.

- 1. Hotel association MSZESZ issued dire warning, saying soaring energy prices coupled with a projected fall in demand will create an even more difficult situation for the sector than during the pandemic. The sector has seen huge growth in domestic tourism this year, boosting room revenues, but costs have risen at a faster pace, MSZESZ President Csaba Baldauf said. "Wage costs have risen to reach 35% of revenue and energy costs have climbed from 10% of total revenues to 20% this year", he added. Many hotel operators turned down offers for one or two-year fixed gas and electricity contracts last year as prices were 150% of the market price at that time, but spot gas and electricity prices on the market are 5 times higher this year.
- **2. Guest nights at hotels in Hungary were up 65%** yr/yr to 1.7 mln in June, but were 19% below prepandemic levels, according to the Hotels and Restaurants Association MSZESZ. In the first half, overnight stays jumped 3.2-fold from the same period in 2021. The number of foreign visitors up 65% to 731,000 in June, accounting for 43% of hotel guest nights. Figures were lifted by the FINA world swimming championship held between June 17 and July 3. Occupancy rates at hotels averaged 53% in June this year, 21% higher than in June 2021, but 13% lower than in June 2019.
- **3. Inflation accelerates to 24-year high:** Annual inflation rose from 11.7% in June to 13.7% in July, the highest since 1998, according to Central Statistics Office (KSH). Among the largest increases, the price of margarine soared by 65.8%, the price of bread by 57.9%, cheese went up by 52.6%, pasta by 49.1%, dairy products by 43.8%, poultry was 38.8%, price of eggs went up by 37.5%. Core inflation excluding energy and seasonal foods reached 16.7% yr/yr in July, up from 13.8% in June. Average yr/yr inflation in the Jan-July period was 10%. Analysts expect higher utility costs and the modification of the fuel price cap may boosting inflation to 16%-20% later this year.
- **4. Consumer protection proceedings launched against Wizz Air:** According to the Justice Ministry, "the number of consumers' complaints have increased of late, of which several cases had major repercussions in the media." The airline has failed to provide information and assistance regarding flight delays and cancellations, and failed to provide accommodation and re-booking to those affected by cancellations, causing passengers financial damage. In addition, it did not respond to consumers' applications within the stipulated 30 days, while raising the fees for customer services calls, violating legal regulations and the rights of consumers.

5. Forint weakened to historic low against dollar to HUF 415.2 on 23 August, beating the previous record low against of 414.4 in July. The dollar meanwhile continued to strengthen against the euro, which fell below parity with the US currency for the first time in 20 years.

In line with European Aviation Safety Agency regulations, large-scale taxiway and runway renovation works will begin. The load-bearing surfaces and curbs of taxiways will be widened in several sections, while the rainwater drainage systems and the lighting network will also be renewed. The project will be implemented in two phases, with the first lasting from August 8 to the beginning of December, with the total cost estimated at Ft 3.5 bln (appx EUR 8.7 mln). The Ft 3.9 bln (appx EUR 9.7 mln) expansion of the forecourt of BUD Cargo City will also begin, thanks to which up to four Fcategory cargo aircraft can be served in parallel in the future instead of the current two. - 1. S&P downgraded its BBB outlook for Hungary, on 12 Aug, from stable outlook to negative, indicating a 25% chance of a downgrade in the next 2 years and highlighted the risks: The danger of losing EU funds and the reduction of Russian gas deliveries which could worsen growth prospects and endanger the budgetary consolidation after the covid epidemic. Wage and price inflation, the volatile forint exchange rate and the expected increase in financing costs also reduce the government's room for manoeuvre. S&P forecasts Hungary's GDP growth to be 5.1% this year, 2.3% in 2023 and 3% in 2025. The agency expects state budget deficits of 4.9% of GDP in 2022 and 3.8% in 2023, dropping below 3% only in 2025. The government's target for 2023 is 3.5%. S&P expects that the government will reach an agreement with the EU on the withheld EU funds, so EU transfers may reach 4% of GDP, on average, in 2023-25. If the EU funds do not arrive and Russian gas shipments stop, then the Hungarian economy may fall into recession next year. At the moment, Hungary is feeling the negative consequences of the energy crisis more than any other country in Europe. That is why, in addition to general risks, the agency sees "special downside risks" in the economy. The special taxes introduced by the government in some sectors mainly affect foreign companies negatively, a fact which may reduce the inflow of capital in the coming years.
- **2.** Hungary's Q2 GDP growth was third highest in the EU, after Slovenia and Portugal, Finance Minister Mihály Varga said. The 6.5% annualised growth in the April-June period was more than 50% above the EU average. "The goal is to preserve the stability and growth of the Hungarian economy, even amid deteriorating circumstances", he added.
- **3.** MNB elevated the base rate to 11.75%, the highest since spring 2004. It also increased the overnight deposit rate from 10.25% to 11.25% and the overnight lending rate from 13.25% to 14.25%. According to analysts the

central bank did as the market expected, citing domestic inflation which could reach 20% and soaring European energy prices which will add to the current account and budget deficits. These will have a weakening effect on the forint which can further increase increase inflationary pressure.

4. MNB will launch three monetary tightening measures starting in the autumn, to support the reduction of interbank liquidity so that short-term money market interest rates develop in line with the central bank's targets, even in a turbulent financial market environment. The compulsory reserve rate is increased for commercial banks from 1% to 5% – whereas the reserve rate is only 2% in Poland – and the MNB will regularly held discount bond auctions. Furthermore, the MNB is opening a long-term deposit facility that sterilises excess liquidity in the banking sector for longer maturities. According to experts, as a result of these measures, liquidity will tighten, and short-term yields will rise and move closer to the benchmark interest rate set by the MNB. MNB Deputy Governor Barnabas Virag said that, it is hoped that, "at least half" of the liquidity will be sucked out of the system by the new instruments. The stock of one-day deposits with the MNB is near Ft 9.5 trn (appx EUR 23.5 bln) of which MNB can siphon away about Ft 5 trn (appx EUR 12.4 bln).

Tariff and Non-Tariff Barriers to Trade:

import Tariffs: The tariff rate on imports averages a comparatively low 1.1% of the value of goods (for international trade), which is the lowest figure regionally and third lowest figure in the whole emerging Europe region. Bosnia's import tariffs are harmonised each year with the combined nomenclature of EU and legislative regulations.

Anti-dumping and countervailing duties: in 2009 Bosnia introduced a law for the protection of domestic products against imports from Croatia and Serbia.

The law stipulates that safeguard measures were necessary owing to the influx of imports and the dumping of particular agricultural products from Croatia and Serbia, as well as a conceivable decrease in exports from Bosnia to Serbia.

Customs and Non-tariff Barriers: as a result of BiH not having EU member status event though the majority of its trading partners are EU member states, export and import supply chains will face more onerous border and documentary times and costs when compared with those of EU states.

The most salient risk is the high cost associated with import border compliance processes, which is higher than that of countries such as North Macedonia and contributes towards Bosnia's status as regional under performer in relation to customs burdens.

Businesses operating in BiH face a high import burden as infrastructural development, industrial capacity and diversification remains weak because of a dearth of fixed capital formation and a lack of political resolve in the country. Imports are driven by the country's need for complex machinery and its energy requirements, such as oil and gas, as well as metals and manufactured goods that cannot be produced locally.

To spur trade, Bosnia has exempted tariff payments from certain equipment that is being imported as part of share capital, with the exceptions of passenger vehicles and slot or gambling machines. To enjoy this benefit, foreign investors must submit a written request to the appropriate customs authority, along with evidence of the investment arrangement and registration of the foreign share. Alternatively, imports into one of Bosnia's four free trade zones are exempt from customs duties and fees. These zones can be found at Vogosca, Visoko, Mostar and Holc Lukavac and clearly mitigate cost risks for businesses seeking to trade internationally with Bosnia.

Bosnia has applied to join the EU, and accession would open up trade, investment and growth opportunities for the economy. The country has already made good strides in establishing free trade and preliminary agreements to speed up the process of EU accession although, political instability threatens the prospect of EU membership in the medium term. Bosnia is also currently discussing the possibility of the creation of a Western Balkans Customs union with its South eastern-Europe counterparts.

ITA BiH: Revenues from indirect taxes higher by 935 million KM compared to 2021: Revenues from indirect taxes in the period January-July 2022 amounted to KM 5.53 bln (EUR 2.83 bln) and are higher by KM 935 mln (EUR 509 mln) or 20.35% compared to the same period in 2021, when it amounted to KM 4.6 bln (EUR 2.35 bln). In the period January-July 2022, the Indirect Taxation Administration returned KM 1.18 bln (EUR 603 mln) to the economy, which is KM 344 mln (EUR 176 mln) more than in the same period last year. The net collected revenues that were distributed to users in the period January-July 2022, namely the state, the entities and the Brcko District, amounted to KM 4.35 bln (EUR 2.2 bln) and were higher by KM 591 mln (EUR 302 mln) compared to the revenues distributed from the single account for the same period in 2021.
- 2. The average monthly net salary in June amounted to 1,126 KM: The average monthly net salary in BiH in June 2022 amounted to 1,126 KM (EUR 575.7) and was higher by 8.1% compared to December 2021, and higher by 13% compared to June 2021 The lowest average net salary was in accommodation services, food preparation and serving and amounted to 730 KM (EUR 373), in construction it amounted to 819 KM (EUR 419), while the average net salary in wholesale and retail trade,

repair of motor vehicles and motorcycles amounted to 879 KM (EUR 449), according to the data of the BiH Statistics Agency.
