Overview of General Barriers to FDI in Hungary:

Regulatory barriers and administrative burden are affecting all sectors but particularly energy, construction, and banking: The overall administrative burden, including start-ups, negatively affects investment decisions. The instability of the regulatory framework, with frequent and unpredictable regulatory changes, creates uncertainty for investors and is hindering both internal investment and FDIs.

The Hungarian government imposes a 100% offset requirement for defined sector investments over HUF 1bln (EUR 2.8 mln). Efficiency of procedures in construction and environmental permits is insufficient; corruption also raises risk for investors. There is no requirement that investors must purchase from local sources, but the EU Rules of origin applies.

Ownership restrictions (all non-EU)

according to the 2014 Land Law, only private Hungarian or EU citizens resident in Hungary with a minimum of three years experience of working in agriculture or holding degree in agriculture can purchase farmland, which is limited to 300 hectares. All others may lease farmland. All farmland purchases must be approved by a local land committee and Hungarian authorities, local farmers and young farmers must be offered a chance to purchase the land first. Up to 1200 hectares for a maximum of 20 years may be leased.

Price controls in consumer facing sectors and others considered to be of strategic importance.

The Hungarian government regulates the prices of certain goods, setting the upper and lower limits to which the private sector must adhere. Sectors include energy, pharmaceuticals. Cuts on regulated utilities prices have put considerable pressure on private utilities companies, decreasing profit margins and adding to an increasingly difficult operating environment.

State intervention in Banking, energy, agriculture, media, telecommunications, and retail sectors.

Since 2012 government has invested in state-owned enterprises with the objective of lessening the participation of foreign-owned competitors, especially in the energy sector. From 1 Jan 2019, the chemical industry, the telecom sector, vehicle construction, metallurgy, optics and electric equipment production, the defence industry, water and sewage management, the financial sector, food industry and agriculture, production of construction materials, state administration, health care, wage management, transport and tourism sectors have been added. Foreign investors in the targeted sectors have expressed concerns that the tax regime has become unpredictable and the additional levies appear to have been aimed against some industries with a high level of foreign ownership.

Basic Rules of The Protection of Strategic assets Concerning Foreign investments

The European Commission has issued Communication 2020/C 99 i/01 in which it has given guidance to the Member States of the EU concerning the protection of Europe's strategic assets from the foreign direct investment, ahead of the application of Regulation (EU) 2019/452 (FDI Screening Regulation) which is applicable from 11 October 2020.Commission Delegated Regulation (EU) 2020/1298 of 13 July 2020 amended the Annex to Regulation (EU) 2019/452.

Hungary first adopted FDI screening mechanisms by act LVII of 2018 for FDIs violating the security interests of the country, then in the economic crisis caused by COVID-19, further screening rules were adopted for FDIs by Government Decree nr. 227/2020. (V.25.). According to the above, certain transactions concerning Hungarian-seated companies operated in strategic sectors by foreign investors shall be reported to the Minister of Finance and the acknowledgement of the Minister of Finance is necessary for the realisation of the acquisition of the shares until 31 December 2020. These transactions include the acquisition of shares, the increase of the registered capital and the transformation of the company. The strategic sectors specified by the Government Decree include energy, communication, finance, agriculture and food industry, healthcare, construction, transport industry, tourism, IT, mechanical engineering, etc. Those foreign investors that have shares in a company registered in the EU, European economic Community or in Switzerland shall only report the transaction if majority interest will be acquired indirectly. Conversely, the foreign investors wishing to acquire shares in a Hungarian company directly have to report any transactions by which the foreign investor would acquire shares at a ratio of at least 10% and the value of the investment is at least 350 000 000 HUF (appx EUR 1 mln). The Minister of Finance has 45 days or in specific and duly justified cases 60 days to decide on the acknowledgement of the transaction. Should the Minister provide a negative decision, then the exact reason of the prohibition is not required to be mentioned. Aggrieved investor may appeal before The metropolitan Court for a review of the prohibiting decision.

On 23rd June 2025 a revised decree came into force introducing two key changes to the earlier framework.

- 1.) The deadline for administrative review has been extended from 30 days to 45.
- 2.) The competent minister may request up to three extensions of 30 working days each, provided the request is submitted in writing before the original deadline passes. Should the minister block a transaction, the state, barring certain exceptions, has 90 days to exercise its pre-emptive right to acquire the targeted firm on the terms outlined in the original agreement. The amended rules also apply retroactively to transactions currently under review.

Banking, agriculture, defence and energy

The Hungarian government has publicly declared that reducing foreign bank market share in the Hungarian financial sector and tightening regulations governing NGOs are key priority areas. Several state-led initiatives over the past several years targeted the banking sector and reduced foreign participation.

- 1. Inflation slows in July, but exceeds forecasts 11 Aug: Consumer prices were up 4.3% yr/yr in July, a slower increase than the 4.6% recorded in June, and were 0.4% higher than in June, with energy and services costs driving the increase, the KSH said. Core inflation eased to 4%, its lowest level since May 2023, but still at the upper edge of the MNB's target. Household energy prices rose 1.2% month-on-month and 10.9% in annual terms, due to a surge in gas consumption. Food prices rose 5.9% yr/yr and 0.3% month-on-month. Without the profit margin cap on food retailers in effect from March, the headline data could have been 1-1.5% higher. Service prices rose by 0.4% compared to June and were up 5.3% yr/yr driven by the peak tourism season. Analysts said the data supports the case for maintaining the current tight monetary policy with the base rate standing unchanged at 6.5% since September 2024. This has helped the forint strengthen to a nine-month high against the euro, at below 396.
- 2. Industrial production fell by 4.9% yr/yr and by 1.2% compared to May, with most manufacturing subsectors recording declines, including the automotive industry, the KSH reported. Industrial exports sank by 5.4% from a year earlier, with vehicle manufacturing exports down 10.5%.. Output of the automotive industry,

which has a 26% share in the manufacturing sector, was 11.5% lower yr/yr in June. Of the 13 manufacturing subsectors, 11 reported lower output. The steepest declines were in chemicals, at 16.7% and electrical appliances at 14.7%. Output of computer, electronics and optical products, as well as wood, paper and printing, came to 5.1% and 3.4%, respectively. In the first half of 2025, industrial output was 3.9% lower than in the same period of 2024, with export sales down 1.6% and domestic sales 3.4% lower.

3. Wage growth near 10% in June: The average gross wage was Ft 704,400 a month in June, up by 9.7% from one year earlier, the KSH said. The average net wage was Ft 484,200, increasing by 9.6% yr/yr. The median gross salary was Ft 567,700 and the median net salary was Ft 395,000, exceeding the amounts in the same periods of 2024 by 10.3% and 10.5%, respectively. Real wages rose by 4.8%, while consumer prices rose by 4.6%. In the first half, gross wages were up by 9.2% to Ft 692,800, while net wages increased by 9% to Ft 476,100. Analysts noted that wage growth in construction has slowed, while in manufacturing it has returned to double-digit levels.

CATL Debrecen CEO reaffirms long-term commitment in Hungary	CATLs first battery cell plant is nearing completion and trial production is expected to begin later this year, with commercial production by year-end, CEO Shen Feng said. The CEO said preparations for a second factory are ongoing. CATL announced plans in the summer of 2022 to invest Ft 3 trillion to build a new EV battery production plant. Shen said the company continues to focus on hiring local staff, while acknowledging layoffs earlier this year, after which local authorities and the Economy Ministry started inspections. Shen stressed that the company acted in line with local labour laws, adding that headcount stands at 800 and CATL is constantly recruiting new employees. He noted that, to support the start of mass production, Chinese professionals may make up 30% of the workforce temporarily before falling below 10% later, similarly to the model at CATLs German facility. CATL has also submitted a request to the local government office to amend its environmental permit as it plans to implement more environmentally friendly and energy-efficient technologies at its factory in Debrecen. The plant's energy consumption will be reduced significantly with the optimisation of manufacturing processes and increased energy efficiency of furnaces.

EC clears state aid for Sunwoda battery plant	The European Commission has approved EUR 264 mln Hungarian state support for the EUR 1.4 bln EV battery factory that Chinese Sunwoda is building in Nyíregyhaza. The incentive package, consisting of a cash grant and tax breaks, was deemed compatible with EU state-aid rules. The Commission accepted the governments argument that the project will bolster regional growth, creating more than 2,500 direct jobs and a further 470 in related industries. The plant will produce lithium-ion cells for electric vehicles.
	3	Rosatom to start Paks II construction in November	Construction of the Paks II nuclear power plant is scheduled to begin in November, with the first concrete pouring, according to Alexey Likhachev, head of Russian nuclear power company Rosatom. The start of construction work has been repeatedly delayed from its original 2024 target. The project foresees two new reactor units alongside the existing Paks plant. The EUR 12.5 bln investment, based on a 2014 Russian-Hungarian agreement, is underpinned by a EUR 10 bln long-term Russian loan. After years of licensing delays, Hungarys nuclear power authority approved construction of a fifth and a sixth unit in August 2022. The European Commission gave further momentum in May 2023 by approving revised contractual and financing terms.

- 1. Hungary not among hardest hit by US tariffs: Hungary sits in the middle range of EU countries affected by US tariffs, with an estimated effective rate of 11.1%, according to calculations by Fitch Ratings. Most EU member states face effective tariff rates above 10%, with only Ireland, Slovenia, Malta, Belgium and the Netherlands below that level. Fitch Ratings' results reflect, in addition to the general 15% tariffs imposed on the EU countries, the 25% burden on cars and parts, and the 50% burden on copper, steel and aluminium. Analysts point out that differences in export composition can significantly alter the real burden on individual economies.
- 2. 4iG S&D sign agreement on satellite programme with Eutelsat, and MoU with Brazilian Condor Nonleathal Technologies: 4iG Space and Defence (4iG S&D), part of the 4iG Group, has signed a binding memorandum of understanding with Eutelsat SA on frequency usage rights and orbital slots for the Husat satellite programme, that was announced on November 20, 2024. While specific orbital positions and frequencies remain confidential, 4iG S&D confirmed that the agreement is crucial for Husat's successful deployment. Eutelsat, with 34 geostationary and some 600 low-Earth orbit satellites, manages satellite positioning and frequency rights in co-operation with international and French regulators. 4IG S&D also signed a non-binding memorandum of understanding with Brazilian firm Condor Indústria Química Condor NonLethal Technologies, a member of the United Arab Emirates-based EDGE Group. The parties agreed to jointly explore and develop the possibility of establishing a regional centre in Hungary for non-lethal, traumatic defence solutions.

Tariff and Non-Tariff Barriers to Trade:

Import Tariffs: The tariff rate on imports averages a comparatively low 1.1% of the value of goods (for international trade), which is the lowest figure regionally and third lowest figure in the whole emerging Europe region. Bosnia's import tariffs are harmonised each year with the combined nomenclature of EU and legislative regulations.

Anti-dumping and countervailing duties: in 2009 Bosnia introduced a law for the protection of domestic products against imports from Croatia and Serbia.

The law stipulates that safeguard measures were necessary owing to the influx of imports and the dumping of particular agricultural products from Croatia and Serbia, as well as a conceivable decrease in exports from Bosnia to Serbia.

Customs and Non-tariff Barriers: as a result of BiH not having EU member status event though the majority of its trading partners are EU member states, export and import supply chains will face more onerous border and documentary times and costs when compared with those of EU states.

The most salient risk is the high cost associated with import border compliance processes, which is higher than that of countries such as North Macedonia and contributes towards Bosnia's status as regional under performer in relation to customs burdens.

Businesses operating in BiH face a high import burden as infrastructural development, industrial capacity and diversification remains weak because of a dearth of fixed capital formation and a lack of political resolve in the country. Imports are driven by the country's need for complex machinery and its energy requirements, such as oil and gas, as well as metals and manufactured goods that cannot be produced locally.

To spur trade, Bosnia has exempted tariff payments from certain equipment that is being imported as part of share capital, with the exceptions of passenger vehicles and slot or gambling machines. To enjoy this benefit, foreign investors must submit a written request to the appropriate customs authority, along with evidence of the investment arrangement and registration of the foreign share. Alternatively, imports into one of Bosnia"s four free trade zones are exempt from customs duties and fees. These zones can be found at Vogosca, Visoko, Mostar and Holc Lukavac and clearly mitigate cost risks for businesses seeking to trade internationally with Bosnia.

Bosnia has applied to join the EU, and accession would open up trade, investment and growth opportunities for the economy. The country has already made good strides in establishing free trade and preliminary agreements to speed up the process of EU accession although, political instability threatens the prospect of EU membership in the medium term. Bosnia is also currently discussing the possibility of the creation of a Western Balkans Customs union with its South eastern-Europe counterparts.

1. Inflation Highest in Two Years in July: The annual inflation rate in BiH (BiH) rose in July from 4.6% in June to 4.8%, making it the highest in two years, or since June 2023, the Statistics Agency announced. Prices in restaurants and hotels increased by 7.5% yr/yr, housing and utility costs by 1.4%, and in the Other Goods and Services category by 3.8%, which in all cases is an acceleration compared to June. In addition, clothing and footwear prices fell by 5.3% yr/yr, and transportation by 3.2%, at a slower pace than in June when the annual price decline was more pronounced.

Economic activity in BiH during the first half of 2025 showed mixed signals: The first quarter of 2025 brought slower growth in GDP (1.7% annualized) compared to the five-year average of 2.7%. Although all components

of GDP recorded growth, the key drivers in the form of private consumption and investment showed significantly weaker dynamics. Private consumption grew by 1.7% compared to the same period of the previous year, while investment activity slowed to 5.5%, which is a much lower growth rate compared to the same quarter of the previous year when investments recorded a significant growth of 18.5%. Additionally, government spending recorded growth of 1.6%, among the lowest post-Covid rates.

2. More Than a Million Overnight Stays in the First Seven Months of 2025 in Sarajevo Canton: In the period Jan-July 2025, the number of tourists was 474,138, an increase of 8.4% compared to the same period last year According to the SC Tourist Board, 108,188 guests were recorded in July, which is an increase of 2.5% compared to July last year. Of these, 98,960 were foreign and 9,228 were domestic guests. The total number of overnight stays in July is 235,855. Of these, 215,956 were foreign and 19,899 were domestic, which is an increase of 0.9% compared to July 2024. The most tourists arrived from: Turkiye, Saudi Arabia, Croatia, Serbia, USA, China, Slovenia, Germany, Great Britain and the united Arab Emirates.

- 1. Average Salary in BiH in June 1,570 KM: The average monthly net salary paid per employee in legal entities in Bosnia and Herzegovina (BiH) for June 2025 was 1,570 KM and is nominally lower by 0.2%, and in real terms by 0.5% compared to the previous month. Compared to June 2024, the average monthly net salary paid is nominally higher by 14.3%, while the real index was higher by 9.2%, according to data from the BiH Agency for Statistics. In information and communications, the net salary paid in June was 2,154 KM, and in finance and insurance activities it was 2,044 KM. In the provision of accommodation, food preparation and service, the average net salary paid in the sixth month was 1,140 KM, in construction 1,250 KM, and in wholesale and retail trade, and repair of motor vehicles and motorcycles 1,293 KM. The average monthly gross salary per employee in legal entities in Bifh for June was 2,435 KM, which shows a nominal drop of 0.3%, and is also lower in real terms by 0.6% compared to May of this year. The average monthly gross salary paid for June compared to the same month last year was nominally higher by 14.4%, while the real index was higher by 9.4%.
- 2. Wood Industry with a Surplus of 547.7 Million KM: The total foreign trade turnover of the wood industry of Bosnia and Herzegovina (BiH) in the first half of 2025 amounted to 1.113 billion KM, which represents a slight decrease of 0.6% compared to the same period last year. The sector continues to achieve a significant surplus, which amounted to 547.7 million KM in that period, but this is a decrease of 3.7% compared to the same period last year. In the first six months of 2025, the wood industry of BiH achieved exports of 830.6 million KM, which is a decrease of 1.6% (less by 13.9 million KM) compared to the same period last year, although 644,326 tons were exported, which is an increase of 7.5% compared to last year's 599,302 tons. According to an analysis by the Foreign Trade Chamber of BiH, this was due to increased quantity of export of raw or semi-finished products but with lower added value.
- **3. 316,927 Unemployed People in BiH at the End of June:** At the end of June 2025, there were 316,927 people registered with employment agencies and services in Bosnia and Herzegovina (BiH). Compared to the previous month, the number of unemployed people increased by 1,433 people or 0.45%. Of the total number of people seeking employment, 188,457 or 59.46% are women. Compared to the same period last year, unemployment in BiH decreased by 8,641 people or 2.65%.
