Overview of General Barriers to FDI in Hungary:

Regulatory barriers and administrative burden are affecting all sectors but particularly energy, construction, and banking: The overall administrative burden, including start-ups, negatively affects investment decisions. The instability of the regulatory framework, with frequent and unpredictable regulatory changes, creates uncertainty for investors and is hindering both internal investment and FDIs.

The Hungarian government imposes a 100% offset requirement for defined sector investments over HUF 1bln (EUR 2.8 mln). Efficiency of procedures in construction and environmental permits is insufficient; corruption also raises risk for investors. There is no requirement that investors must purchase from local sources, but the EU Rules of origin applies.

Ownership restrictions (all non-EU)

according to the 2014 Land Law, only private Hungarian or EU citizens resident in Hungary with a minimum of three years experience of working in agriculture or holding degree in agriculture can purchase farmland, which is limited to 300 hectares. All others may lease farmland. All farmland purchases must be approved by a local land committee and Hungarian authorities, local farmers and young farmers must be offered a chance to purchase the land first. Up to 1200 hectares for a maximum of 20 years may be leased.

Price controls in consumer facing sectors and others considered to be of strategic importance.

The Hungarian government regulates the prices of certain goods, setting the upper and lower limits to which the private sector must adhere. Sectors include energy, pharmaceuticals. Cuts on regulated utilities prices have put considerable pressure on private utilities companies, decreasing profit margins and adding to an increasingly difficult operating environment.

State intervention in Banking, energy, agriculture, media, telecommunications, and retail sectors.

Since 2012 government has invested in state-owned enterprises with the objective of lessening the participation of foreign-owned competitors, especially in the energy sector. From 1 Jan 2019, the chemical industry, the telecom sector, vehicle construction, metallurgy, optics and electric equipment production, the defence industry, water and sewage management, the financial sector, food industry and agriculture, production of construction materials, state administration, health care, wage management, transport and tourism sectors have been added. Foreign investors in the targeted sectors have expressed concerns that the tax regime has become unpredictable and the additional levies appear to have been aimed against some industries with a high level of foreign ownership.

Basic Rules of The Protection of Strategic assets Concerning Foreign investments

The European Commission has issued Communication 2020/C 99 i/01 in which it has given guidance to the Member States of the EU concerning the protection of Europe's strategic assets from the foreign direct investment, ahead of the application of Regulation (EU) 2019/452 (FDI Screening Regulation) which is applicable from 11 October 2020.Commission Delegated Regulation (EU) 2020/1298 of 13 July 2020 amended the Annex to Regulation (EU) 2019/452.

Hungary first adopted FDI screening mechanisms by act LVII of 2018 for FDIs violating the security interests of the country, then in the economic crisis caused by COVID-19, further screening rules were adopted for FDIs by Government Decree nr. 227/2020. (V.25.). According to the above, certain transactions concerning Hungarian-seated companies operated in strategic sectors by foreign investors shall be reported to the Minister of Finance and the acknowledgement of the Minister of Finance is necessary for the realisation of the acquisition of the shares until 31 December 2020. These transactions include the acquisition of shares, the increase of the registered capital and the transformation of the company. The strategic sectors specified by the Government Decree include energy, communication, finance, agriculture and food industry, healthcare, construction, transport industry, tourism, IT, mechanical engineering, etc. Those foreign investors that have shares in a company registered in the EU, European economic Community or in Switzerland shall only report the transaction if majority interest will be acquired indirectly. Conversely, the foreign investors wishing to acquire shares in a Hungarian company directly have to report any transactions by which the foreign investor would acquire shares at a ratio of at least 10% and the value of the investment is at least 350 000 000 HUF (appx EUR 1 mln). The Minister of Finance has 45 days or in specific and duly justified cases 60 days to decide on the acknowledgement of the transaction. Should the Minister provide a negative decision, then the exact reason of the prohibition is not required to be mentioned. Aggrieved investor may appeal before The Metropolitan Court for a review of the prohibiting decision.

Banking, agriculture, defence and energy

The Hungarian government has publicly declared that reducing foreign bank market share in the Hungarian financial sector and tightening regulations governing NGOs are key priority areas. Several state-led initiatives over the past several years targeted the banking sector and reduced foreign participation.

- 1. Factory gate prices were 11.2% higher yr/yr in May, slowing from a 15.9% increase in the previous month, the Central Statistics Office (KSH) said. On a monthly basis, producer prices shrank by 1.6% as domestic output prices fell by 2% and export prices by 1.4%. On an annual basis, export prices fell by 1.1%, but prices for domestic sales leaped up by 36.5%, boosted by energy prices. Domestic prices in the manufacturing sector, increased by 9.3%. Export prices rose by 3.2%. Factory gate prices were 22.3% higher in the first 5 months than in the same period of last year, as prices for domestic sales grew by 48.8% and export prices increased by 9.4%.
- 2. Volume of industrial production dropped by 6.9% in May yrlyr. Seasonally and workday-adjusted data show a rise in output by 1.6% from April to May. Industrial exports expanded by 0.3% yr/yr by volume, but domestic industrial sales volume was 18.4% lower. Manufacturing output went down by 5%. Output plunged by 33% in mining and by 32% in the energy sector. Manufacturing sales volume decreased by 1.6% yr/yr in May. Domestic volume went down by 11.4% while the export volume increased by 2.6%. Exports accounted for 73% of manufacturing sales. Production of vehicles and vehicle parts went up by 10.5%. Within this manufacturing of cars expanded by 10.1% while car parts production went up by 11% The production of electronic devices expanded by 13.4%. The output of the pharmaceutical industry, which has a low weight in the total, expanded by 6.7%, due to increased exports while domestic sales decreased.
- **3. Inflation edges down to 20%:** annual inflation rate slowed to 20.1% from 21.5% in May, the KSH said. On a monthly basis, prices edged up 0.3%. Food prices were 29.3% higher, yr/yr but fell on a monthly basis for the first time in two years, sinking by 0.4% from May. Household energy prices grew by 34.3% yr/yr and motor fuel prices by 20.2%. Consumer durables went up by 6.1%, and service prices by 14.4%, up from a 14.3% rise in May. The MNB emphasised that the rate of core inflation, which excludes volatile fuel and food prices, fell by 2% to 20.8%. Economic Development Minister Marton Nagy said disinflation could gain pace in the second half.
- **4. Gov't slaps carbon-tax on heavy polluters:** A recently announced new carbon-dioxide quota tax levied on Hungary's biggest emitters is expected to generate Ft 90 bln (appx EUR 238 mln) revenue. The regulation is applicable to companies with annual CO2 emissions of 10,000 tonnes or more. Companies whose emissions exceed the level will pay the new tax and will have to buy carbon credits on the market. The new Hungarian carbon levy includes a tax of €40 per tonne of carbon dioxide and a 10% transaction fee. The targeted sectors include construction material makers the oil and chemical industry and fertiliser maker Nitrogenmuvek.

	1	BorsodChem inaugurates new plants (EUR 430 mln)	BorsodChem, owned by Chinese Wanhua Group, has completed a Ft 160 bln (appx EUR 430 mln) series of investments at its plant in Kazincbarcika, which includes a thermal power plant and added production capacities in nitric acid, nitrobenzene and aniline. The new capacities will be 90,000 tonnes annually at the nitric acid plant, 240,000 tonnes at the nitrobenzene plant and 200,000 tonnes at the aniline plant. The European Commission approved a EUR 44.5 million tax credit for the investment, Minister of Foreign Affairs and Trade Peter Szijjarto said at the ceremony. This equals roughly 10 percent of the investment value. Despite the energy crisis and the war, BorsodChem realised EUR 3 bln in sales in 2022, of which 82 percent came from exports, the company said in a statement. Combined investments at the chemical company, which will celebrate 75 years of operation in 2024, came to EUR 1 bln over the past four and a half years.

The Ft 580 bln (appx EUR 1.5 bln) investment by one of the top ten global EV battery makers is the largest investment in Hungary in 2023 and the third exceeding EUR 1 bln in value, he added. Sunwoda will invest Ft 93 bln (appx EUR 246 mln) in the initial phase. Hungary is the fourth largest producer of EV batteries in the world and with Sunwoda, f out of the top 10 EV battery manufacturers in the world, with a combined 49.4 percent

3	Suzuki will expand Esztergom plant (EUR 24 mln)	Suzuki is spending Ft 9.3 bln (appx EUR 24 mln) to expand production capacity at its Esztergom plant, and to take a big step towards making the factory carbon-neutral, Foreign Affairs and Trade Minister Peter Szijjarto said. The state will provide a Ft 1.9 bln (appx EUR 5 mln) subsidy, to contribute to job creation, he said, as the expansion will raise the number of Suzuki employees in Hungary to 3,000. Suzuki will expand the capacity of its bumper manufacturing, painting and welding units. The Japanese carmaker is also buying high-tech machinery and is building a solar power plant.			
4	Liberty Steel to purchase Dunaferr (EUR 55 mln)	With a EUR 55 mln bid, Liberty Steel Central Europe, a subsidiary of the Indian-British group, has won the tender for acquiring the companies that own the assets of Dunaferr steel works under liquidation. The winning bidder was registered on Jan 10, and has been renting Dunaferr assets since then. Setting up the subsidiary helped to ease the arrival and customs clearance of the raw materials used in the steelworks and the expansion of production. The successful sale of Dunaferr is an important milestone, but the hard work is just beginning, the Economy Development Ministry commented. The government is committed to a green transition of the company, which is crucial for the future of the steel industry. The factory needs a reorganization, as significant improvements are necessary for the production of higher value-added products, and the production of green steel, the ministry added. Liberty Steel already owns steelworks in the region in Ostrava, Czech Republic and in Galati, Romania. Dunaferr has accumulated debts of Ft 500 bln (appx EUR 1.3 bln), and the company that acquires it must not only pay the purchase price, but an immediate investment of at least Ft 37 bln (appx EUR 98 mln) is necessary for Dunaferr to get back its lost environmental protection permits. - 1. S&P affirmed Hungary's BBB sovereign rating with a stable outlook saying that macroeconomic pressures have largely eased since January, when the credit-rating agency downgraded the country's rating to one notch above the investment grade threshold. S&P said policymakers have shifted to tighter fiscal and monetary settings to narrow the country's elevated twin deficits and level off an overheated economy and it expects that fiscal consolidation will continue, reducing the state debt in relation to GDP. Economic growth will be marginal in 2023, at around 0.1% with the contraction of household demand, which is offset partially by rising exports and FDI.
- 2. Gov't modifies law on windfall profits: The government has modified the windfall profit tax for oil companies, airlines and pharmaceutical companies by a decree. Under the new rules, oil companies must themselves calculate the windfall profit tax payable for 2023 and 2024. The tax rate will fall from the present 2.8% to 1% next year, suggesting that this tax will be phased out after 2024. The windfall tax on drugmakers can be reduced by investment as well as by research and development projects. The maximum of the deduction is 50%. The deduction can only be made from the 40% tax on drugs costing Ft 10,000 or more at the production cost level. The 20% tax on drugs costing less than Ft 10,000 remains unchanged. Mining royalty rules are also changed making the royalty progressive, depending on production quantities. So far, the mining royalty was 24% on contracted amounts, 42% on amounts sold on the free market and 18% on test production. From September, the mining levy will depend on the extracted value. For 28,000-55,000MWh of gas the tax will be 48%, falling to 42% for sales on the free market and 36% for test production. Above this threshold, the tax rates will be 62%, 56% and also 56%, respectively. The mining royalty must be paid for the amount contracted with the mining authority even if the production falls short of it. The windfall tax on airlines is modified only to include Israel in the lower tax category, so in theory, flights to Israel can be somewhat cheaper. At present, Israel is in the same category as the EU.
- 3. Agriculture Minister asks EU to maintain ban on Ukrainian grain: Hungary and other Central European member states have requested that the EU ban on imports of Ukrainian grain be extended to the end of the year from its current end date of September 15, Agriculture Minister István Nagy said after meeting with his EU counterparts in Brussels on 26 July. He said the lifting of the EU ban cannot be justified by any professional argument.

Tariff and Non-Tariff Barriers to Trade:

import Tariffs: The tariff rate on imports averages a comparatively low 1.1% of the value of goods (for international trade), which is the lowest figure regionally and third lowest figure in the whole emerging Europe region. Bosnia's import tariffs are harmonised each year with the combined nomenclature of EU and legislative regulations.

Anti-dumping and countervailing duties: in 2009 Bosnia introduced a law for the protection of domestic products against imports from Croatia and Serbia.

The law stipulates that safeguard measures were necessary owing to the influx of imports and the dumping of particular agricultural products from Croatia and Serbia, as well as a conceivable decrease in exports from Bosnia to Serbia.

Customs and Non-tariff Barriers: as a result of BiH not having EU member status event though the majority of its trading partners are EU member states, export and import supply chains will face more onerous border and documentary times and costs when compared with those of EU states.

The most salient risk is the high cost associated with import border compliance processes, which is higher than that of countries such as North Macedonia and contributes towards Bosnia's status as regional under performer in relation to customs burdens.

Businesses operating in BiH face a high import burden as infrastructural development, industrial capacity and diversification remains weak because of a dearth of fixed capital formation and a lack of political resolve in the country. Imports are driven by the country's need for complex machinery and its energy requirements, such as oil and gas, as well as metals and manufactured goods that cannot be produced locally.

To spur trade, Bosnia has exempted tariff payments from certain equipment that is being imported as part of share capital, with the exceptions of passenger vehicles and slot or gambling machines. To enjoy this benefit, foreign investors must submit a written request to the appropriate customs authority, along with evidence of the investment arrangement and registration of the foreign share. Alternatively, imports into one of Bosnia's four free trade zones are exempt from customs duties and fees. These zones can be found at Vogosca, Visoko, Mostar and Holc Lukavac and clearly mitigate cost risks for businesses seeking to trade internationally with Bosnia.

Bosnia has applied to join the EU, and accession would open up trade, investment and growth opportunities for the economy. The country has already made good strides in establishing free trade and preliminary agreements to speed up the process of EU accession although, political instability threatens the prospect of EU membership in the medium term. Bosnia is also currently discussing the possibility of the creation of a Western Balkans Customs union with its South eastern-Europe counterparts.

Bosnia and Herzegovina (BiH) was visited by 566,207 tourists in the first five months of 2023, which is 23.3% more than in the same period last year. Tourists spent 1,202,826 overnight stays in this period, which is 20.2% more than in the first five months of 2022, the BiH Statistics Agency said. Overnight stays by foreign tourists is higher by 36.6% compared to last year. In the structure of overnight stays by foreign tourists, the most overnight stays were made by guests from Croatia, 21.9%, followed by Serbia with 17.8%, Slovenia 8.9%, Turkey 5.9%, Germany 4.3%, Montenegro 3.6%, while tourists from other countries accounted for 34.6%.

- 1. EBRD Eight million euros loan to support investments in digitization and new technologies in BiH: The European Bank for Reconstruction and Development (EBRD) approved a loan of eight million euros to Sparkasse Bank, which the bank will direct to local clients small and medium-sized enterprises. The funds will be used to help small businesses invest in the automation and digitization of business processes to improve their productivity, operational efficiency and resilience. Small and medium-sized enterprises will be able to apply for funds to invest in hardware and software for various digital transformation projects in the area of production, internal processes and services. The goal is to encourage the digital transformation of small and medium sized enterprises and make them more competitive on the European Union markets, and their operations aligned with the standards required by EU directives. In addition to loans, SMEs will benefit from incentives in the form of grants worth up to 15% of the total loan amount. These incentives are financed by the European Union.
- 2. Decline in industrial production was recorded: seasonally adjusted industrial production in BiH in June 2023, compared to May 2023, recorded a decrease of 5.5%, and compared to June of 2022, calendar adjusted, a decrease of 7.6%. Industrial production in the period January-June 2023 compared to the same period last year fell by 4.4%, according to the data of the BiH Statistics Agency. In the first half of this year, compared to the same period last year, the decline in mining and quarrying amounted to 8.8%, and in the processing industry 5%. A decline was recorded in most branches of the manufacturing industry, so in the production of food products it was 4.2%, leather and related products 15.9%, textiles 37.5%, and base metals 26.3%. Growth of 10.8% was registered in the production of basic pharmaceutical products and pharmaceutical preparations, production of motor vehicles, trailers and semi-trailers grew by 22.1%, and the production of furniture by 0.7%. In the production and supply of electricity and gas for six months of 2023 compared to the same period last year, a 0.9% decrease was recorded.
