The new Regulation 2021/2246 came in force in Romania on 6th of January, 2022.

# Industrial Production Prices Up By 52.3% In July 2022 Compared To July Last Year but budget deficit increased in 2022

Industrial production prices for the total (domestic market and non–domestic market) increased by 52.3% in July 2022 compared to July 2021, says the latest report by the National Institute of Statistics (INS). In July 2022, industrial production prices for the total (domestic market and non-domestic market) were up 5.2% from June 2022. The consolidated general budget deficit increased to 1.94% of the Gross Domestic Product (GDP) after the first seven months of this year, from 1.71% of GDP in the first half of 2022, according to data from the Ministry of Finance.

### Seasonally adjusted unemployment rate down to 5.2 percent in July

The unemployment rate in July went down 0.2 percentage points, to 5.2 percent, as against the one registered in the previous month, and it was 1.5 percentage points higher among men, as per the National Institute of Statistics (INS).

### National Bank of Romania forex reserves reach 42,851 million euros in August 2022

As of August 31, 2022, the foreign exchange reserves of the National Bank of Romania (BNR) stood at 42,851 million euros, compared with 42,768 million euros on 31 July 2022, according

#### to the bank.

## Romania's headline inflation eases marginally in July to just under 15%

Consumer prices increased by 0.9% in July, and the annual inflation edged down marginally under 15% YoY from just over 15% YoY in June, as per Romania's statistics office INS.

## MFP: Government debt-to-GDP ratio climbs to 50 pct as of end May

The government debt as of end-May 2022 was RON 614.338 billion, up from RON 602.871 billion in the previous month, shows data centralized by the Public Finance Ministry (MFP). The government debt-to-GDP ratio rose to 50 percent from 49.2 percent at the end of April.

# AgriMin Daea: Wheat harvesting completed nationwide, production enough for domestic consumption and export

Minister of Agriculture Petre Daea said that wheat harvesting has been completed nationwide and that the official figures will be announced soon; he also specified that this year's harvest is enough to ensure both domestic consumption and export. In 2021, Romania's wheat production rose to 10.32 million tonnes, compared to 6.4 million tonnes in 2020, according to provisional data from the national statistics office.

# Romania attracted the second-highest foreign direct investments in 2021 in its region, according to the Emerging Europe Investment Promotion Report of this year.

Roughly USD 8.61 bln flowed into Romania last year. Investments into Romania were notably higher in 2021 relative to previous years, when the FDIs that the country managed to attract were negatively impacted by the pandemic.

In 2017, foreign investors committed USD 5.41 bln to their projects in Romania, followed by USD 6.21 bln in 2018, USD 5.79 bln in 2019, and USD 3.43 bln in 2020. Despite its recent success in attracting FDI, Romania is still only tenth in the region when it comes to FDI per capita. Romania, second destination for FDI in the region after Poland.

# Cereals, processed cereal-based products' exports exceeded two billion euros in first 5 months of 2022

Romania exported cereals and processed cereal-based products in the amount of 2.155 billion euros, during the first five months of this year, which is 77.2% more when compared to the similar period in 2021, according to the centralized data from the National Institute of Statistics (INS). On the other hand, during the period of January-May 2022, Romania imported cereal and processed cereal-based products of 683.5 million euros (16.3%). The trade surplus on this sector of products stood in the first five months at almost 1.472 billion euros.

# Iohannis: I welcome German Chancellor's announcement regarding Romania's accession to Schengen, a strategic objective of our country

On 29 August, President Klaus Iohannis sent a message on Twitter thanking German Chancellor Olaf Scholz for Germany's support for Romania's Schengen accession, noting that this is a strategic objective for our country, which meets all the technical requirements.

Scholz is not the only European leader who voiced support for Romania's accession to Schengen, others did, too, while the European Parliament voted for this several times. During his visit to Romania in June 2022, the President of France, Emmanuel Macron, said that "France is with Romania" regarding the accession to the Schengen area. During the past years, Germany and the Netherlands have been the main opponents of Romania's accession to the Schengen Area.

By joining the Schengen Area, Romanian citizens and cargo carriers will no longer have to go through the border check procedure with member states in Schengen, which will lead to a significant shortening of waiting times at the border. For example, if Romania and Bulgaria also enter Schengen, the road to Greece will no longer be marked by long waits at Romanian-Bulgarian customs and Bulgarian-Greek customs.

### UiPath becomes largest IT company in Romania

UiPath, the IT unicorn founded by Daniel Dineş, became the largest IT company in Romania after registering a turnover of over RON 1.2 bln (EUR 246.5 mln) in 2020, according to official data from the Ministry of Finance. UiPath's net turnover in 2020 was almost double (+89%) compared to the RON 644.9 mln reported in 2019.

### Cluj, most business-friendly city in Romania for second year running

Cluj-Napoca is Romania's most business-friendly city for the second year running, according to the Emerging Europe Business Perception Index for 2022. A business-friendly city must be conducive to the creation and development of businesses. The Polish city of Łódź, for example, took first place in this year's ranking.

### Trade between Romania and Germany reached 18.4 billion euros in first 6 months

The volume of trade between Germany and Romania amounted to 18.4 billion euros in the first half of this year, up 12.3% compared to the same period in 2021, according to figures from the Federal Bureau of Statistics (Destatis), quoted by AHK Romania. Thus, exports to Romania amounted to 9.8 billion euros, the equivalent of an increase of 8.8%, compared to the reference period, while Germany's imports from Romania amounted to 8.6 billion euros, increasing by 16.6%.

#### Gov't approves list of irrigation facilities that will be re-classified as public utility

The government approved the list of irrigation facilities that will be re-classified as public utility; also, the national program for the rehabilitation of the main irrigation infrastructure will receive until 2027 as much as 1.5 billion euros in allocations from the national budget. Concretely, this financing will increase the economic viability of the irrigation systems," the government's spokesperson Dan Carbunaru told a press conference at the Victoria Palace. He also specified that new irrigation systems would be built by increasing the number of projects from 101 to 189, as plans are afoot to expand Romania's irrigated surface from 1.8 million hectares to 2.6 million hectares.

### Romanian SMES to receive EU support


Commission approves a €358 million Romanian scheme to support companies affected by the coronavirus pandemic The European Commission has approved a Romanian scheme of up to €358 million (approximately RON 1.7 billion) to support companies in the context of the coronavirus pandemic. The scheme was approved under the State aid Temporary Framework. The measure will be open to micro, small and medium-sized companies affected by the coronavirus pandemic and active in sectors, such as manufacturing, wholesale and retail trade, and accommodation.

## **<u>10. Any other issue of importance</u>**

#### Exports of goods registered 1.7-fold increase in first half of year

In the first half of the year, exports of goods amounted to 2290.4 million US dollars, 1.7 times more than in the same period last year. According to the National Bureau of Statistics, exports of domestic goods amounted to 1,705.5 million US dollars (74.5% of total exports), increasing 1.7 times compared to the same period of 2021, a fact that contributed to increasing the total value of exports by 54.3%.

Most goods exported to: Romania (29.0%), Ukraine (10.8%), Turkey (9.2%) and Italy (8.5%). Road transport remains the most frequently used for goods exports (73.1%), followed by maritime transport (16.6%), rail transport (9.6%) and air transport (0.7%). In the same period, merchandise imports totaled 4347.0 million US dollars, 33.1% more than the same period last year. The top countries of origin of goods imports were: Romania (16.2%), the Russian Federation (15.3%), China (9.4%) and Ukraine (9.1%).

## Moldovan producers exported first plums from this year's harvest and Moldovan apple producers forecast harvest of 485 thousand tons this year

The first quantities of early Moldovan plums, from the 2022 harvest, were exported during July, the Moldova Fruit Association announced. According to the Association, the more than 3,400 tons of plums reached consumers in 11 countries of the world: Germany, Austria, Poland, Holland, Romania, Russia, etc. The European Commission has increased for the Republic of Moldova, for one year, the amount of plums that can be traded without customs duties in the European Union, from 15 thousand to 40 thousand tons. In 2021, Moldova exported more than 52 thousand tons of plums, half of which reached the EU market.

In 2022, Moldovan producers will have a harvest of about 485 thousand tons of apples. Iurie Fală, executive director of the Moldova Fruit Association made the statement. He presented the forecast and prospects for the apple sector in the Republic of Moldova at the annual

Progrosfruit Conference, organized by the World Association of Apple and Pear Producers (WAPA). "Due to unfavorable weather conditions, this year's apple harvest will be 180 thousand tons less, compared to last year. In the top of the varieties produced in Moldova, Idared, Golden Delicious, Gala and Florina remain the most important," said Fală.

### Moldova received 75 million euros of European support in context of energy crisis

The European Commission transferred 75 million euros to the Republic of Moldova as budget support, considering the difficult energy situation the country is facing," the official writes. The European Union continues to support the citizens of the Republic of Moldova who face increasingly high gas prices.

## European Commission transferred first installment of macro-financial assistance of 150 million euros for Moldova

The European Commission transferred the first installment of 50 million euros from the macro-financial assistance of 150 million euros for the Republic of Moldova. The announcement was made by MEP Siegfried Mureşan, on a social network. According to the official, of the 50 million euros, 35 million are loans under favorable conditions and 15 million are non-refundable European funds.

"The macro-financial assistance of 150 million euros was adopted by the European Union to help the Republic of Moldova cover part of its financing needs determined by the management of the refugee crisis, the energy crisis, the COVID-19 pandemic and other consequences of the war of Russia in Ukraine", said Siegfried Muresan.

## Honey Bee Festival organized in Chisinau

The second edition of the Bee Honey Festival takes place on August 20-21, in Chisinau. Iurie Scripnic, state secretary at the Ministry of Agriculture and Food Industry (MAIA) participated in the opening of the event, who addressed a message of congratulations and encouragement to beekeepers and beekeepers. "Thank you for your perseverance, professional dedication and hard work," he said.

#### **Customs duties**

Albania uses the Harmonized Code System for tariff classification. The customs duty rates range from 0% to 15%, depending on the type of goods. Import of machinery and equipment for use in the taxpayer's business activity are generally subject to customs duties at the zero rate. Import of vehicles are subject to customs duties at a rate of 0%.

#### **Excise duties**

Excise duty is a tax applicable to certain goods consumed in Albania, whether imported or produced in the country. Albanian excise legislation is based on EU Council Directive 2008/118/ EC, which defines common provisions applicable for all excisable goods. It also integrates specific provisions applicable for each category of excise products. Categories of products subject to excise duty in Albania are:

- •Energy products (e.g. petroleum, gasoil, gas).
- •Tobacco products (e.g. tobacco, cigarettes).
- •Alcohol and alcoholic beverages (e.g. beer, wine, spirits).
- •Other products (e.g. baked coffee, fireworks).

Excise duty is usually calculated as an amount per quantitative measuring unit defined for that product (e.g. per litre, per kilogram, per hectolitre, per 1,000 pieces).

#### **10. Any other issue of importance**

#### Minister Optimistic over Country's Economy

The Minister of Economy and Finances, Delina Ibrahimaj was optimistic on country's economy. According to her, the economy is on the right way and the inflation reached 7.5% on July, the lowest level in the Region. We have more stabilised prices and economy. We are better than a year ago.

#### Economic growth is projected at 4.1% in 2022

The government predicts moderate economic growth in the medium term, at a time when the public debt will continue to remain at high levels. In the draft document of the medium-term budget programs 2023-2025, the economy is expected to grow at an average rate of 4% per year. After the strong recession of 3.5% in 2020, the government states that the economy has started to recover strongly in 2021, estimated at 8.7% and is expected to continue the positive trend in the following medium term. Economic growth is projected at 4.1% in 2022 and is projected to average around 4% per year over the next medium-term period 2023-2025.

#### Public Debt to Drop to 72% of GDP by 2025

As per Government of Albania, the level of public debt is expected to decrease to 72.1% of GDP in 2025, from the level of 74.8% of GDP predicted for 2022, despite the very positive results during 2022; while tax revenues are predicted at the level of 27.5% of GDP in 2025, from 26.8% that is predicted for 2022.

#### In Jan-June 2022 Albania imported more items

According to INSTAT data, for the period January-June 2022, total imports reached 446 billion ALL (3.7 billion euros), from 354 billion ALL (2.9 billion euros), with an annual increase of 25.9%. In value, there are 92 billion lek (760 million euros) more spent by the economic actors of the country to buy less goods than the same period of the previous year. INSTAT data show that in the first 6 months of the year, imports in quantity recorded a decrease of 6.2%.

#### Electricity Import Costs Reach EUR 280 Mln in Albania

Import costs have reached over 280 million EUR, and according to the government's negative scenario, they could reach 680 million EUR by the end of the year. Meanwhile, price for household energy consumers will no longer be the same in Albania, starting next month. Those who consume more than 800 kilowatts/hour per month will have to pay for the amount consumed above this limit, a price that is expected to be several times

higher than the current quota of 9.5 ALL per kilowatt/hour.

#### **Durrës-Port of Strategic Importance**

The European Union through the Transport Community recently assessed that the Port of Durrës in Albania is of strategic importance for maritime transport in the region as they connect it to the main European transport network. The discrepancy for the Port of Durrës refers to the partial rail connection, as currently only the eastern port terminal is connected to the national rail network, so its multimodal dimension is currently very limited. The EU emphasizes that, regarding the ports of Durrës and Vlora in Albania, local authorities have decided that both ports will be transformed into large modern marinas. The current commercial port will be transferred to the Integrated Commercial Port of Durres in Porto Romano (9 km NW of Durres) and the current Port of Vlora will be transferred to the Integrated Commercial Port of Triport, Vlora (11 km north of Vlora.

#### Road tax collection in Albania registered a significant boost after COVID

The government collects at least 10 times more from the fuel sales tax, which is designed to pay for road maintenance by its users. In 2021, the receipts from this tax were around 160 million euros. Increase in trade & commerce and movement of tourists after COVID resulted higher tax collection. The fiscal burden aimed at road maintenance was high, as the government is collecting direct taxes on national roads, starting with the National Road and other national roads are planned.

#### PM Claims Number of Tourists Entering Albania Is 'Beyond All Predictions'

Prime Minister Edi Rama declared that the number of tourists entering Albania during this 2022 summer season has surpassed "every prediction". Through the social networks, the Albanian Head of Government proclaimed that there has been an "extraordinary flow" of foreign visitor arrivals entering the country these days in the Port of Durrës, as he wished a "good day" to his fellow citizens.
