Overview of General Barriers to FDI in Hungary:

Regulatory barriers and administrative burden are affecting all sectors but particularly energy, construction, and banking: The overall administrative burden, including start-ups, negatively affects investment decisions. The instability of the regulatory framework, with frequent and unpredictable regulatory changes, creates uncertainty for investors and is hindering both internal investment and FDIs.

The Hungarian government imposes a 100% offset requirement for defined sector investments over HUF 1bln (EUR 2.8 mln). Efficiency of procedures in construction and environmental permits is insufficient; corruption also raises risk for investors. There is no requirement that investors must purchase from local sources, but the EU Rules of origin applies.

Ownership restrictions (all non-EU)

according to the 2014 Land Law, only private Hungarian or EU citizens resident in Hungary with a minimum of three years experience of working in agriculture or holding degree in agriculture can purchase farmland, which is limited to 300 hectares. All others may lease farmland. All farmland purchases must be approved by a local land committee and Hungarian authorities, local farmers and young farmers must be offered a chance to purchase the land first. Up to 1200 hectares for a maximum of 20 years may be leased.

Price controls in consumer facing sectors and others considered to be of strategic importance.

The Hungarian government regulates the prices of certain goods, setting the upper and lower limits to which the private sector must adhere. Sectors include energy, pharmaceuticals. Cuts on regulated utilities prices have put considerable pressure on private utilities companies, decreasing profit margins and adding to an increasingly difficult operating environment.

State intervention in Banking, energy, agriculture, media, telecommunications, and retail sectors.

Since 2012 government has invested in state-owned enterprises with the objective of lessening the participation of foreign-owned competitors, especially in the energy sector. From 1 Jan 2019, the chemical industry, the telecom sector, vehicle construction, metallurgy, optics and electric equipment production, the defence industry, water and sewage management, the financial sector, food industry and agriculture, production of construction materials, state administration, health care, wage management, transport and tourism sectors have been added. Foreign investors in the targeted sectors have expressed concerns that the tax regime has become unpredictable and the additional levies appear to have been aimed against some industries with a high level of foreign ownership.

Basic Rules of The Protection of Strategic assets Concerning Foreign investments

The European Commission has issued Communication 2020/C 99 i/01 in which it has given guidance to the Member States of the EU concerning the protection of Europe's strategic assets from the foreign direct investment, ahead of the application of Regulation (EU) 2019/452 (FDI Screening Regulation) which is applicable from 11 October 2020.Commission Delegated Regulation (EU) 2020/1298 of 13 July 2020 amended the Annex to Regulation (EU) 2019/452.

Hungary first adopted FDI screening mechanisms by act LVII of 2018 for FDIs violating the security interests of the country, then in the economic crisis caused by COVID-19, further screening rules were adopted for FDIs by Government Decree nr. 227/2020. (V.25.). According to the above, certain transactions concerning Hungarian-seated companies operated in strategic sectors by foreign investors shall be reported to the Minister of Finance and the acknowledgement of the Minister of Finance is necessary for the realisation of the acquisition of the shares until 31 December 2020. These transactions include the acquisition of shares, the increase of the registered capital and the transformation of the company. The strategic sectors specified by the Government Decree include energy, communication, finance, agriculture and food industry, healthcare, construction, transport industry, tourism, IT, mechanical engineering, etc. Those foreign investors that have shares in a company registered in the EU, European economic Community or in Switzerland shall only report the transaction if majority interest will be acquired indirectly. Conversely, the foreign investors wishing to acquire shares in a Hungarian company directly have to report any transactions by which the foreign investor would acquire shares at a ratio of at least 10% and the value of the investment is at least 350 000 000 HUF (appx EUR 1 mln). The Minister of Finance has 45 days or in specific and duly justified cases 60 days to decide on the acknowledgement of the transaction. Should the Minister provide a negative decision, then the exact reason of the prohibition is not required to be mentioned. Aggrieved investor may appeal before The Metropolitan Court for a review of the prohibiting decision.

Banking, agriculture, defence and energy

The Hungarian government has publicly declared that reducing foreign bank market share in the Hungarian financial sector and tightening regulations governing NGOs are key priority areas. Several state-led initiatives over the past several years targeted the banking sector and reduced foreign participation.

- 1. Consumer prices were up 25.7% yr/yr in January, the highest level in 27 years, up from 24.5% in the previous month, as per data from the Central Statistical Office (KSH). On a monthly basis, prices rose by 2.3%. Core inflation, which excludes volatile fuel and food prices, rose to 25.4% from 24.8% in December, which suggests that underlying inflationary pressures remain quite strong. According to forecasts inflation in 2023 will exceed last year's 14.5% level at 17-18%..
- 2. Airport traffic at 75% of 2019 levels: Passenger traffic at Liszt Ferenc International rose 121% to 12.2 million last year and reached 75% of the record level reported in 2019, the last year before the pandemic, operator Budapest Airport said. Airlines flew to 140 destinations last year on level with the number in 2019. The most popular destinations were London, Tel Aviv and Paris. Cargo volume at Liszt Ferenc climbed 6% to a record 194,000 tonnes last year, which is 44% above 2019 levels.
- **3. Economy fell into recession in the fourth quarter of 2022** as GDP shrank by 0.4% from the third quarter, according to the KSH. GDP also shrank from the second quarter to the third, by 0.7%. However, GDP increased by 4.6% in the whole year of 2022. On a yr/yr basis, GDP was up by 0.4% in the fourth quarter, and by 0.9% according to seasonally and workday adjusted data.
- **4. Number of Guest nights was up by 22% in December** yr/yr, at 1.738 million, the KSH said. Foreign guest nights saw a dramatic 44.4% yr/yr rise to 908,000 million, with number of foreign guests increasing by 52% to 352,000. President Zoltán Guller of tourism agency MTÜ said that visitor numbers in 2022 as a whole were only slightly below pre-pandemic levels. In the full year 2022 foreign guest nights more than doubled, rising by 106.1% to 11.337 mln.
- **5. Industrial price growth slows to 34.9% yr/yr in December,** down from 37.0% a month earlier, the KSH said. Domestic sales prices rose by 62.9%, and export sales by 20.7%. Domestic industrial producer prices increased by 34.5% in manufacturing, which has a 62% weight in the total, but shot up by 130% in the energy industry, with a weight of 33%. Export prices in manufacturing, with a weight of 96%, rose by 19.5%, while those in the energy sector, with a weight of 3.8%, went up by 42.9%.
- 6. The GVH competition authority launched an investigation into Wizz Air, as it suspects that the low-cost airline is withholding important information or revealing it late on its online platforms in order to influence ticket buyers in the direction of more expensive options. Following a comprehensive analysis completed last October, the GVH firmly warned airlines to change their methods of imperceptibly distorting consumer decisions in their ticket sales and advertising practices.

- **1. Wage growth at 18% in December:** The average gross wage was Ft 581,900 (appx EUR 1473) a month in December, up by 18.1% from one year earlier, the Central Statistics Office (KSH) said. The average net wage was Ft 387,000 (appx EUR 980), also up by 18.1%. Despite the large increase, real wages fell by 5.1%, compared to a year earlier. In the whole year of 2022, average gross wages were 17.5% higher on average year-on-year at Ft 515,500 (appx EUR 1304). Real wages were 2.6% higher than a year earlier, as average inflation was 14.5%.
- **2. Minimum wage second lowest in EU:** The minimum monthly wage in Hungary was €579 in January, the second lowest in the EU after Bulgaria, where it was €399, according to Eurostat. A year ago Hungary's minimum wage was higher those of Romania and Latvia, as well as Bulgaria. Comparing net wages, the monthly minimum is Ft 152,950 in Hungary and Ft 157,000 in Romania. in terms of purchasing power parity, Hungary occupies the sixth lowest place in the overall ranking with €947.91, the same as the Czech figure. The respective figures are €1,274 in Poland, €1,109 in Romania and €780 in Slovakia.
- **3. EC raised its GDP and inflation forecasts for Hungary:** In 2023 GDP is expected to grow at 0.6%, with average annual inflation at 16.4%, up from the 15.7% projected earlier. Economic growth is forecast to remain subdued as the economy gradually adjusts to higher energy prices. At the start of the year, private consumption is set to fall, as high inflation squeezes household purchasing power. Changes in retail energy subsidies and the removal of the fuel price cap in December will boost annual inflation, which is expected to decelerate to 4% in 2024. The EC stresses that the economic outlook for Hungary remains sensitive to global investor sentiment and spotlights the country's exposure to energy price changes and potential supply disruptions because of its high dependence on energy imports.

Tariff and Non-Tariff Barriers to Trade:

import Tariffs: The tariff rate on imports averages a comparatively low 1.1% of the value of goods (for international trade), which is the lowest figure regionally and third lowest figure in the whole emerging Europe region. Bosnia's import tariffs are harmonised each year with the combined nomenclature of EU and legislative regulations.

Anti-dumping and countervailing duties: in 2009 Bosnia introduced a law for the protection of domestic products against imports from Croatia and Serbia.

The law stipulates that safeguard measures were necessary owing to the influx of imports and the dumping of particular agricultural products from Croatia and Serbia, as well as a conceivable decrease in exports from Bosnia to Serbia.

Customs and Non-tariff Barriers: as a result of BiH not having EU member status event though the majority of its trading partners are EU member states, export and import supply chains will face more onerous border and documentary times and costs when compared with those of EU states.

The most salient risk is the high cost associated with import border compliance processes, which is higher than that of countries such as North Macedonia and contributes towards Bosnia's status as regional under performer in relation to customs burdens.

Businesses operating in BiH face a high import burden as infrastructural development, industrial capacity and diversification remains weak because of a dearth of fixed capital formation and a lack of political resolve in the country. Imports are driven by the country's need for complex machinery and its energy requirements, such as oil and gas, as well as metals and manufactured goods that cannot be produced locally.

To spur trade, Bosnia has exempted tariff payments from certain equipment that is being imported as part of share capital, with the exceptions of passenger vehicles and slot or gambling machines. To enjoy this benefit, foreign investors must submit a written request to the appropriate customs authority, along with evidence of the investment arrangement and registration of the foreign share. Alternatively, imports into one of Bosnia's four free trade zones are exempt from customs duties and fees. These zones can be found at Vogosca, Visoko, Mostar and Holc Lukavac and clearly mitigate cost risks for businesses seeking to trade internationally with Bosnia.

Bosnia has applied to join the EU, and accession would open up trade, investment and growth opportunities for the economy. The country has already made good strides in establishing free trade and preliminary agreements to speed up the process of EU accession although, political instability threatens the prospect of EU membership in the medium term. Bosnia is also currently discussing the possibility of the creation of a Western Balkans Customs union with its South eastern-Europe counterparts.

EU signs EUR 70 mln Financing Agreement for Energy Support Package for BiH: The Financing Agreement for the Energy Support Package worth EUR 70 mln that will provide assistance to Bosnia and Herzegovina's most vulnerable households to cope with rising prices and support energy transition. A further EUR 10 mln be disbursed to improve the energy efficiency of 4000 residential buildings, while another EUR 10 mln has been allocated for around 400 Micro, Small and Medium Enterprises that are facing challenges as a result of the energy crisis. Medium to long-term support will be available in grants through the EU's Economic and Investment Plan (EIP) for the Western Balkans. These grants will support energy transition through support for the construction of renewable energy projects and the upgrading of energy transmission systems, district heating and schemes for energy efficiency for old apartment buildings. It will also support energy security, by improving gas and electricity infrastructure, including interconnectors. The Energy Support Package can be a starting point for BiH's energy transition and BiH authorities should use the coming period to design projects to fully benefit from the available funds, the EU Delegation to BiH announced.

- 1. Standard and Poor's: outlook increased from stable to positive: S&P has increased the credit rating outlook from stable to positive, and kept the credit rating of Bosnia and Herzegovina the same, at the level of 'B'. It said political stability in BH has improved in recent months, with the timely formation of the state-level government, following the general elections held in October 2022. Another positive turn is that in December 2022, BH was granted a candidate status for EU membership. S&P analysts expect economic growth to slow down in 2023 and reach 1% with the general government net debt being at a low 22% of GDP at the end of 2022, and expected to remain at that level until the end of 2023. The economy has shown resistance to recent external shocks such as the COVID-19 pandemic, and the sharp rise in commodity prices due to the Russian-Ukrainian conflict. It is expected that the current account deficit will remain high this year, but it will mostly be financed from the net inflow of foreign direct investments and the capital account surplus.
- 2. Average net salary in BiH in December 2022 amounted to 1,190 KM (EUR 608.4) and was nominally higher by 1.3% compared to November 2022, and was nominally higher by 14.2% compared to December 2021, according to the data of the BiH Statistics Agency. The average monthly gross salary per employee in BiH for December 2022 was 1,831 KM (EUR 936.2), which shows a nominal growth of 1.3% compared to November 2022, and a nominal growth of 14.1% compared to December 2021.
- 3. Annual Inflation is Expected to Decrease: The International Monetary Fund (IMF) forecasts a decrease in average annual inflation in Bosnia and Herzegovina (BiH) to 6% in 2023, and to 3% in the following year. "According to our projections, the real growth of the gross domestic product in 2023 is projected at 2%, and 3% in 2024", said IMF resident representative for BiH Andrew Jewel, emphasizing that these projections are still very uncertain.
