During the calendar year 2022, both exports and imports from/to India have registered a healthy growth via-a-vis the corresponding period last year 2021. Figures show a new record of exports in the current calendar year 2022 from USD 1080 million in CY 2021 to USD 1395 million in CY 2022, registering a growth of 29.16%. In the same period the imports to India rose from USD 1825 million USD in CY 2021 to USD 2728 million USD, registering a growth of 49.5%. India imports a large number of phosphates, fertilizers and derivatives, whose prices have increased significantly in year 2022.

On a consolidated basis, heavy engineering goods cotton, automotive, defense, rice, organic and inorganic chemicals are key items of export from India to Morocco. There has been some demand

slow down in electronic goods, pharmaceuticals and coffee, tea and spices. Due to inflation and high freight tariff, the export got impacted. Despite the headwinds, the gross merchandise export from India has touched all time high. It is expected that this trend is likely to continue in the calendar year 2023 as well.

In the current financial year, while demand for engineering goods, petroleum and agri commodities remained strong, there has been some demand slow down in chemicals, pharma and electronic goods. Indian exports have diversified from the traditional exports like textiles, cotton and spices and new commodities /goods are being exported to Morocco, signifying the broadening base of the Indian exports in the Moroccan market.

Macro economic indicators

(I). Foreign Direct Investments to Morocco Rise by Nearly 20%

The flow of Foreign Direct Investments (FDIs) into Morocco rose by 19.8% over the first two months of 2023, according to Office d'Echange (OE) data. In a monthly publication, OE data showed that Foreign Direct Investments in Morocco reached MAD 5 billion (\$493 million) at the end of February, up from MAD 4 billion (\$394 million) a year earlier. Despite the notable post-pandemic recovery, the flow of FDIs remains below pre-pandemic levels. The volume of FDI in the first two months of 2019 settled at MAD 6 billion (\$592 million), OE data indicated.

(II). IMF Approves \$5 Billion Crisis Prevention Credit Line for Morocco

The Executive Board of the International Monetary Fund (IMF) has approved a two-year arrangement for Morocco under the Flexible Credit Line (FCL) of about US\$5.0 billion. The arrangement will enhance Morocco's external buffers and provide insurance against plausible tail risks on a temporary basis.

(III). Remittances from Moroccan Diaspora Reaches \$1.7 Billion in February 2023

Remittances from Moroccans residing abroad (MRE) totaled nearly MAD 17.3 billion (\$1.7 billion) by the end of February 2023, up from MAD 13.45 billion (\$1.3 billion) the previous year, the Office d'Echange (OE) reported. The number represents an increase of 28.6% compared to a year earlier, the office noted.

(IV). ONSSA grants import licenses to 250 farmers for 'cannabis' seeds

The National Office for Health Safety of Food Products (ONSA) has granted licenses to 10 companies to import cannabis seeds for 250 farmers and more than 20 cooperatives. The licenses granted came after applications submitted by a total of 12 importers for 330 farmers, and were submitted by the National Office for Health Safety of Food Products, while the seeding phase is expected to begin next May, planting the first legal crop in the Kingdom. The country's Customs and Indirect Tax Administration issued on a circular including conditions and measures that are part of the implementation of Law 13-21 on the legal use of cannabis.

(V). Revenue from Tourism exceeded USD 9 Billion in 2022

Morocco has experienced a very strong recovery since the opening of the borders in March 2022. Head of Government told the Parliament that between March and December 2022, Morocco received 11 million tourists, a 292% and 391% increase over 2021 and 2020, respectively. The Head of Government noted that the country's tourism revenues in foreign currency reached MAD 16 billion (\$1.5 billion) in January and February of this year 2023. The revenues show a recovery rate of 400% compared to the same period in 2022 and a 51% recovery rate compared to the same period in 2019.Domestic tourism revenues have also increased significantly, he said, mentioning that the number of overnight stays [tourist accommodation] has doubled compared to 2021, exceeding 19 million, which represents an increase of 192%.

Morocco- External

(I). Morocco-Brazil Bilateral Trade Hit 'Historic High' of \$3.13 Billion in 2022

Bilateral trade between Morocco and Brazil has reached a \$3.13 billion, attributing the change to opening up the Moroccan market to new Brazilian products. Morocco exported goods worth MAD 10.96 billion (\$1 billion) in February due to to phosphates and derivatives sales. Brazil and Morocco have emphasized their determination to boost cooperation in all fields, including agriculture.

(II). China: New Step to Promote Investments in Morocco

The Moroccan Agency for the Development of Investment and Exports (AMDIE), organized18-23 April, a roadshow in the People's Republic of China, intended to promote Morocco's destination among Chinese investors. The Moroccan delegation at this roadshow, was led by the Minister Delegate to the Head of Governemnt in charge of Investment, Convergence and Evaluation of Public Policies, Mohcine Jazouli, accompanied by the Director General of AMDIE, Ali Seddiki. The second stage of this roadshow took place in the Chinese capital Beijing, where high-level bilateral meetings will be held with the leaders of Chinese institutions, including the Vice Minister of Foreign Affairs in charge of South-West Asia and North Africa, and the Minister of Commerce.

(III). Moroccan Minister of economy held Joint Economic Committee meeting with the UAE counterpart

The Moroccan Minister of Economy and Finance Nadia Fattah, co-chaired the Ministerial meeting of the Committee's inaugural session in Rabat with Abdullah Marri, the United Arab Emirates' Minister of Economy. This meeting was preceded by a bilateral meeting between the two Ministers which resulted in the signing of a memorandum of understanding on economic and technical cooperation between the the two countries through the establishment of a joint Moroccan-Emirati Economic Committee. **Meanwhile trade between UAE and Morocco has** increased by 16% in 2022 compared to 2021, reaching \$1 billion. The data shows the UAE as Morocco's second Arab trading partner in 2021; it also puts the Gulf country among Morocco's top 20 trading partners worldwide.

(IV). Trade Between Morocco, Argentina Reaches \$1.5 Billion in 2022

Trade between Argentina and Morocco has reached \$1.5 billion in 2022, data compiled by Argentina's Institute of Statistics and Censuses (INDEC), a 48% increase compared to trade recorded between the two countries in 2021. Morocco's imports from Argentina amounted to nearly \$944 million, an increase of 39% compared to 2021. Meanwhile, Morocco's exports to Argentina reached \$548 million, an increase of over 68% from the 2021 figure of \$326 million. Argentina's main imports from Morocco include cars, salt, sulfur, cement, machinery, mechanical parts, and electrical equipment. Argentina's exports to Morocco include cereals, animal and vegetable oils, animal feed, and fish products. Trade between the two countries has tripled over the past five years, moving from \$642.9 million in 2017 to \$1.5 billion in 2022.

(V). Morocco Acquires \$524 Million HIMARS Artillery Systems from US

The United States State Department approved the sales of the Mobility Artillery Rocket Systems (HIMARS) and related equipment for an estimated cost of \$524.2 million to Morocco, according to a statement from the US Defence Security Cooperation Agency. The statement specifies that the Moroccan government requested to purchase 18 M142 High Mobility Artillery Rocket System (HIMARS) launchers, 40 M57 Army Tactical Missile Systems (ATACMS), and 36 M31A2 Guided Multiple Launch Rocket Systems (GMLRS) Unitary. The extensive list of equipment also includes 36 M30A2 Guided Multiple Launch Rocket Systems (GMLRS) Alternative Warheads, 9 M1152A1 High Mobility Multipurpose Wheeled Vehicles (HMMWV), and 18 International Field Artillery Tactical Data Systems (IFATDS). The shipment also features camouflage screen and support systems, support equipment, communications equipment, spare and repair parts, test sets, and laptop computers among other equipment

OCP, Fertilizer and Phosphate news

(I) Morocco's Phosphate Exports Drop by 25% in 2023

After breaking records in 2021 and 2022, the monetary value of Morocco's phosphate exports dropped by 25% year-on-year in the first two months of 2023, according to Office d'Echange data(OE). In a monthly update, OE data shows that phosphate exports in the first two months of 2023 settled at MAD 10.9 billion (\$1 billion), down from MAD 14.6 billion (\$1.4 billion) the previous year. The drop in the monetary value coincides with the overall easing of prices on the international market.

Companies

(I). Chinese contractor to build green hydrogen project in Morocco

Chinese energy engineering procurement and construction contractor Energy China has signed a memorandum of understanding with Saudi conglomerate Ajlan Bros and Morocco's Gaia Energy to build a green hydrogen project in Morocco. The project describes a green ammonia plant with future output of 1.4

million tonnes per annum -produced from about 320,000 tonnes of green hydrogen - with a 2 gigawatt photovaltic solar plant as well as a 4 GW wind power project.

(II). LG Energy Solution to Source Lithium From Morocco

LG Energy Solution (LGES) signed a memorandum of understanding with Yahua, a Chinese lithium compounds maker, to procure lithium from the Chinese producer based in Morocco.

(III). Octopus Energy, TAQA Invest £30 million in Morocco-UK Xlinks Power Project

British renewable energy group Octopus Energy and Abu Dhabi National Energy Company TAQA have invested £30 million (MAD 379 million) in the Moroccan-British power project, which would deliver green energy from Morocco to the UK through the Xlinks subsea cable. Xlinks is a high voltage direct current (HVDC) submarine cable between the UK and Morocco, crossing Portugal, Spain and France. It will provide UK with 3.6 GW of renewable electricity, or nearly 8% of the country's needs, to power seven million British homes by the end of the decade.
