During the calendar year 2022, both exports and imports from/to India have registered a healthy growth via-a-vis the corresponding period last year 2021. Figures show a new record of exports in the current calendar year 2022 from USD 1080 million in CY 2021 to USD 1395 million in CY 2022, registering a growth of 29.16%. In the same period the imports to India rose from USD 1825 million USD in CY 2021 to USD 2728 million USD, registering a growth of 49.5%. India imports a large number of phosphates, fertilizers and derivatives, whose prices have increased significantly in year 2022.

As per DGFT trade data, during the FY 2022-2023 exports from India to Morocco reached USD1047.15 against USD 962.28 in 21-22, registering a growth of 8.82%. As regard imports from Morocco, total value for the period 2022- 2023 stood at USD 2,549.44 as compared to USD 2,244.19 in 2021- 2022 registering a growth of 13.60% on y to y basis, due mainly to the increase in prices of fertilizers and their derivatives. The first two month of the current FY 2023-24, has seen total exports of USD 138.2 million from India to Morocco (April -May 2023)

Bilateral

(I). International Year of Millets 2023:

The Embassy of India in the Kingdom of Morocco organised month long events to mark Interational Year of Millets 2023. These events were held in Rabat and Marrakesh. The main event was held in the Oberoi Marrakesh orgnized in the first week of June 2023 where a large number of local dignitaries, diplomats and media personnel gathered. A poster exhibition, display of various millets and millet based food festival were main attractions. The event was also supported by Federation de La Millorette, which is also engaged in promotion of millet based foods. Ambassador in his speech highlighted the importance of millets for health benefit but also an important step for food security and crop diversification.

(II). Inauguration of the new plant of the Indian group Indore Composite

Ambassador Mr. Rajesh Vaishnaw participated to the inaurugation of the new plant of the Indian group Indore Composite. The new unit located within the Tanger Med industrial platform, is dedicated to the production of composite materials for various sectors, including telecommunications, renewable energies, transportation, and construction. With a total investment of €15 million, the facility uses cutting-edge technologies and highly efficient processes with the aim of minimizing environmental impact and reducing waste. The industrial site spans an impressive area of 20,000 square meters, enabling the annual production of 2.5 million kilometers of cable. The plant is set to create over 400 employment opportunities, further contributing to the region's economic growth.

(III) Webinar on Indian Defence Products with the Moroccan Ministry of Defence:

Indian Embassy in association with Ministry of Defence (Defence Production) and PHDCCI organised a webinar on June 2023 where some of the biggest Indian companies like Tata Advanced, Bharat Electronics, DCM Shriram, L&T, MKU, Starwire, Zen Technologies and others participated and showcased their range of products to the Moroccan buyers. Officials from the Royal Armed Forces, Royal Moroccan Navy and Air Force showed great intrest in the Indian products and requested for further follow up meetings. Discussions were also held for possible visit by an Indian delegation to Morocco and vice versa.

Internal

Macro economic indicators

(I). Morocco's Tourism Revenues Reached Over \$4.1 Billion in May

Morocco's tourism revenues reached over MAD 40.63 billion (\$4.1 billion) for the period Jan -May 2023 registering a 100 % growth as compared to same period last year. Morethan 5 million tourists visited the country as of the end of May 2023. The number represents a growth rate of 20 % compared to the same period in the year 2019, when the tourism sector witnessed a milestone prior to the COVID-19 pandemic.

(II). EBRD Provides €50 Million Credit Line to Bank of Africa to Support Moroccan Small, Medium Businesses

The European Bank for Reconstruction and Development (EBRD) announced issuing a €50 million credit line for Bank of Africa - BMCE Group (BOA) to facilitate lending to micro, small, and medium-sized enterprises (MSMEs) in Morocco. This initiative aims to enhance the resilience and competitiveness of Morocco's private sector.

(III). Morocco's Diaspora Remittances Reached \$4.5 Billion in May

Remittances from Morocco's diaspora reached MAD 45.1 billion (\$4.5 billion) in the first five months of 2023, according to recent data from Morocco's Exchange Office. Morocco's remittances have been growing since the COVID crisis, moving from MAD 24.1 billion (\$2.4 billion) in 2020, to MAD 37.42 billion (\$3.76 billion) in 2021, and MAD 39.2 billion (\$3.94 billion) in 2022.

(IV). Bank Al-Maghrib Leaves Key Interest Rate Unchanged at 3%

Morocco's central bank, Bank Al-Maghrib (BAM), announced that it will not raise interest rates, signaling a pause in its tightening cycle of monetary policy. The decision by the board of Bank Al-Maghrib came after three consecutive rate hikes, totaling 150 basis points, and aimed at maintaining stability by keeping the key rate unchanged at 3%.

(V). World Bank Approves two loans to support Reforms in Morocco

The World Bank has approved a \$450 million loan to support Morocco's health reforms to make the health care system in the North African country "more inclusive." Besides this, he World Bank's Board of Directors approved a substantial \$350 million loan to Morocco to bolster the country's social protection efforts. The World Bank (WB) explained that the additional financing complements the initial \$400 million program granted in 2020 and the financing demonstrates the international community's commitment to supporting Morocco's efforts in mitigating the impacts of the COVID-19 crisis and advancing comprehensive social protection reforms.

(VI). Growth in Morocco's Agriculture Contracted by Nearly 13% in 2022

Growth in Morocco's agriculture reached historic low levels in 2022 as a result of adverse weather conditions mainly very less rainfall resulting into 13 % decrease in the agri output of the country. In a

report on the overall economic situation in 2022, HCP data indicated that the suboptimal performance of Morocco's economic growth in 2022 - which stood at 1.3% - was mainly driven by the drop in agriculture input. Meanwhile, non-agricultural economic activities recorded a 3% growth.

(VII). OECD Projects Morocco's Economic Growth to Average 3.5% in 2023

Morocco's economy is poised for a recovery, with growth projected to reach 3.5% in 2023 and 3.7% in 2024, according to the latest OECD Economic Outlook. The positive outlook is attributed to the easing of global economic tensions and a rebound in foreign demand for Moroccan goods and services. The country's agricultural sector is expected to make a stronger contribution to economic activity compared to previous years due to higher rainfall during the winter season, coupled with healthy tourist inflows.

Morocco- External

(I). Morocco- Nigeria Gas Pipeline Advanced Through New Agreements Signing

Morocco and Nigeria are advancing efforts towards the implementation of the mega pipeline project aiming to benefit several countries in West Africa. Morocco's Hydrocarbon and Mines Office (ONHYM) signed four Memorandam of Understanding (MoUs) with the Nigerian National Petroleum Company Limited (NNPC) with petroleum operators in four countries, including the Republic of Guinea, Liberia, Benin, and Cote d'Ivoire. The project will allow Morocco to host 1,672 kilometers of the pipeline which will benefit over 400 million people in West Africa.

(II). Morocco to Receive Sherpa Vehicles From France

Morocco has signed contract to get Renault-made Sherpa, light armored vehicles from France. The vehicles are equipped with Mistral 3, a very short range air defense missile system. Mistral 3 is currently in service with the French armed forces. It can be used from vehicles as well as surface ships and helicopters.

(III). Morocco and Netherlands Launch €300 Million Investment Fund for Green Initiatives

A Memorandum of Understanding (MoU) was signed by Moroccan Minister of Economy and Finance Nadia Fettah, the Dutch Prime Minister Mark Rutte and CEO of Invest International Joost Oothuizen in order to promote cooperation between the two countries in the field of renewable energy. The agreement inttends to establish a €300 million (MAD 3.2 billion) investment fund to finance projects in the fields of infrastructure, water, agriculture, and renewable energy. The fund will be managed by Invest International, a Dutch organization that invests in developing countries. Of the €300 million, 35% percent will be in the form of a grant, while the rest will be a loan, according to the Ministry of Economy and Finance.

(IV). Morocco, Germany Cooperation to Create 9,500 Jobs in Fiber Optic Engineering

Morocco and Germany have colloborated to launch an innovative pilot project focused on the installation of fiber optic networks. The project is set to create a wave of employment opportunities for 9,500 individuals in the field of civil engineering. The two countries reached the agreement during a

meeting held in Geneva, on the sidelines of the Global Summit on Social Justice organized by the International Labor Organization.

(V). Israeli Defense Giant Elbit Systems Plans to Establish Two Sites in Morocco

Elbit Systems, an Israeli defense technology company, has announced plans to open two sites in Morocco, Shai Cohen, Head of Israel's liaison office in Rabat, said during a press conference. Elbit Systems is renowned for its expertise in developing and implementing advanced defense solutions.

OCP, Fertilizer and Phosphate news

(I). OCP to Invest \$7 Billion in Green Ammonia Plant in Southern Morocco

Morocco's state-owned phosphate giant, OCP Group, has announced its plans to invest \$7 billion in the construction of an ammonia plant in Tarfaya, southern Morocco, that will utilize green hydrogen produced from renewable sources. OCP Group, a major ammonia importer, faced significant expenses of \$2 billion last year due to global price increases resulting from the conflict in Ukraine.

Companies

(I). China's Tinci to Open Electric Vehicle Battery Plant in Morocco

Guangzhou Tinci Materials Technology, one of China's leading manufacturers of materials for electric vehicle batteries, will open a plant in Morocco, as per the local news reports wih an investment of MAD 2.8 billion (\$282,061 million).

(II). Atlas Group, BG Motors Join Forces to Launch First African-Built Electric Car

Atlas Group, an Anglo-Moroccan technology company aiming to launch the first African-designed and engineered BEV (Battery Electric Vehicle), announced the signing of a Memorandum of Understanding (MoU) with BG Motors, a leading importer, marketer, and retailer of vehicles in Israel. The document forms the broad outline of an agreement between the parties to facilitate the commercial development and assist with sales and after-sales services when the production of the first Atlas EV starts in 2027.

(IV). American Aerospace Manufacturer Pratt & Whitney Expands to Morocco

American Aerospace Manufacturer Pratt & Whitney has ann plans to establish an affiliate, Pratt & Whitney Maroc (PWM), in Casablanca. In a press release, the company stated it aims to manufacture detailed static and structural machined parts for various engine models, noting that construction will begin in the fourth quarter of 2023 to start the commercial production in year 2025.

(V). Predator Oil & Gas Identifies New Gas Reservoirs in Morocco

New Jersey-based oil and gas company, Predator Oil & Gas Holdings released a positive interim drilling update for its MOU-3 well, announcing that it had identified two new potential gas reservoirs. Predator Oil's operations unveiled a substantial drilling break between 339 and 350 meters in depth, which was identified as the source of the gas.
