

D. ECONOMY

1. Cargo ship initiates direct trade link between Sittway, Rakhine State, and Kolkata, India September 26, 2023

Sittway, Rakhine State, is set to establish direct trade relations with Kolkata, India, through the deployment of a cargo ship, according to U Aung Aung, General Secretary of the Rakhine State Chambers of Commerce and Industry. A recent development permits cargo vessels traversing local coastlines to dock at the Sittway Jetty, a significant component of the Kaladan Multi-Modal Transit Transport Project located in Sittway Township.

2. CBM revokes money changer licences of 166 companies during seven months

September 21, 2023

A total of 166 money changers have had their money changer licences revoked in the past seven months (from March to September) as they failed to comply with the rules and directives issued by the Central Bank of Myanmar (CBM).

3. Trade Dept allows exports of only agricultural produce, fisheries at Sittway border

Only agricultural produce and fisheries will be allowed for export via Sittway border, the Trade Department under the Ministry of Commerce. This action is to ensure systematic border trade with Bangladesh and promote trade, according to the news bulletin 15/2023 released on 1 September. It came into effect starting from 4 September, the Trade Department notified. The agro produce and fisheries include rice and broken rice, various pulses, sesame, peanut, onion and freshwater and saltwater fish.

<u>4. Visa exemption extended to diplomatic, special passport holders from four more countries</u> September 21, 2023

Myanmar expands visa-free entry to 24 nations, including four new additions. Yangon International Airport announced on 18 September that diplomatic passport holders and special passport holders from four additional foreign countries are now eligible for visa exemptions. This list includes four newly added countries: Belarus, Morocco, Nepal, and Japan. Among the 24 nations are Bangladesh, Brazil, China, Colombia, India, South Korea, North Korea, Mongolia, Russia, Serbia, Sri Lanka, and nine ASEAN member countries. This expanded visa exemption scheme aims to foster stronger diplomatic ties and encourage increased tourism between Myanmar and these nations.

5. E-commerce guide published for all online trade and services

September 13, 2023

The Ministry of Commerce has issued an E-commerce guide for all businesses selling trade and services through the Internet, including online shops. The guidelines state that all those who will be engaged in E-commerce business in Myanmar must register in the registration system managed by the Ministry of Commerce and must comply with the law specified by the relevant field. In addition to this, E-commerce operators must disclose the methods and information to resolve any dispute regarding the address and phone number registered on the website or social network where they are selling goods.

6. Gold price dips to K3.4 mln per tical

September 27, 2023

The price of gold slumped to K3.4 million per tical (0.578 ounce or 0.016 kilogramme) in the grey market. Along with the Kyat depreciation against the US dollar at K4,000, the pure gold price hit an all-time high of K4 million per tical in August. The pure gold price fell again to K3.4 million per tical with the Kyat devaluation against the US dollar slowing at approximately K3,300 in the unauthorized market. Mandalay Gold Entrepreneurs Association (MGEA) sold over seven visses of pure gold at a special price in two weeks of June to stabilize the gold price.

7. Myanmar earns over 1.28 bln USD from agricultural exports in nearly 5 months

Myanmar earned over 1.28 billion U.S. dollars from agricultural exports in the first nearly five months (from April 1 to Aug. 25) of the 2023-24 fiscal year, according to data released by the Ministry of Commerce. Myanmar mainly exports agricultural, animal and marine products, minerals, forest products and manufactured goods to its foreign trade partners including China, Thailand, Bangladesh and India.

8. Myanmar attracts less foreign direct investment in 5 months

Foreign direct investment that flowed into Myanmar plunged over 60.66 percent year on year to more than 484 million U.S dollars in the first five months of the 2023-24 fiscal year, according to the Directorate of Investment and Company Administration (DICA). Foreign investors who made investments in Myanmar during the five-month period included China, India, South Korea, Samoa, Singapore, Britain and the United States.

9. Foreign currencies to be sold to importers of construction, agriculture, transport, energy-related materials

The foreign currencies will be sold to importers of construction materials, agriculture, transport and energy-related materials via land borders, according to the Ministry of Commerce. The imports include steel, iron, polymer, insecticide, fertilizer, solar and machinery. The current plan to sell foreign currencies online to importers is intended for seven products imported through border camps under the permission of Foreign Exchange Supervisory Committee-FESC. Moreover, the ministry will review the remaining imports and sell the currency to importers. Currently, there are border trade routes such as Myanmar-China, Myanmar-Thailand, Myanmar-Bangladesh, Myanmar-India and Myanmar-Laos.

10. Myanmar's foreign trade soars past US\$13 bln in last five months

Myanmar's external trade totalled over US\$13 billion in the past five months (Apr-Aug) of the current Financial Year 2023-2024, according to the Ministry of Commerce. Myanmar's export was worth over \$6.484 billion whereas the country's import was valued at \$7.213 billion in the past five months. Myanmar's seaborne trade value crossed over \$9.587 billion this FY, while border trade was valued at \$4.1 billion.

11. Myanmar pulses exports earn over US\$580 mln in past five months

Myanmar shipped more than 720,000 tonnes of pulses, with an estimated value of over \$580 million, to foreign countries over the past five months (Apr-Aug) of the current financial year 2023-2024, according to the Ministry of Commerce.

Myanmar mainly exports black gram, green gram and pigeon peas to foreign markets. Of them, black gram and pigeon peas are mostly sent to India. India has growing demand and consumption requirements for black gram and pigeon peas. According to a Memorandum of Understanding between Myanmar and India signed on 18 June 2021, India will import 250,000 tonnes of black gram and 100,000 tonnes of pigeon peas (tur) from Myanmar for five consecutive years from 2021-2022 financial year to 2025-2026 FY. This G-to-G pact will not affect the pulses' annual quota set by India. Myanmar's exporters are also entitled to deliver the pulses to India under that annual quota.

12. New visa policy welcomes Chinese, Indian tourists to Myanmar

It is reported that Chinese tourists and Indian tourists can visit Myanmar with visa-on-arrival. The Ministry of Immigration and Population under the SAC (State Administration Council) has declared that, commencing from the first day of a one-year probationary period, Chinese and Indian tourists arriving by air will be granted Tourist Visas on Arrival in accordance with COVID-19 prevention measures. From August 30th 2023, until August 2024, Chinese and Indian tourists will be eligible for Tourist Visas on Arrival

13. Myanmar entrepreneurs invited to World Food India 2023

Business people in Myanmar have been invited to participate in World Food India 2023, scheduled to be held in New Delhi from 3 to 5 November, as announced by the Union of Myanmar Federation of Chambers of Commerce and Industry (UMFCCI). The event will feature participation from food manufacturers, equipment manufacturers, logistics companies, cold storage operators, entrepreneurs, and retailers from various countries.

14. Sittway Port included in Kaladan Multi-Modal Transit Transport Project start allows coastal ships to dock

The Rakhine State Chamber of Commerce and Industry (RSCCI) has announced that domestic coastal ships can now dock at Sittway Port under the India-Myanmar Friendship Kaladan Multi-Modal Transit Transport Project. The statement said that the RSCCI can get the necessary advice to dock the ship. The RSCCI announced in 2022 that the new Sittway Port, which is a part of the Kaladan Multi-Modal Transit Transport Project (KMTT), will be able to accept ships with 5,000 or 6,000 deadweight tons. According to the India-Myanmar Friendship Program, the new Sittway port of the KMTT, which has been completed, will soon be operational. About 5000-6000 deadweight tons ships will be able to berth.
